Transportation Plan to Ensure School Stability for Students in McKinney Vento

Duration of Transportation

If transportation to school of origin is required in order to maintain school stability for students in McKinney Vento, Colorado River Union HSD#2 will collaborate with the local child welfare agency (CWA) if needed to ensure that transportation will be provided for the duration of the child(ren)'s time in McKinney Vento.

How Transportation Will Be Provided, Arranged, and Funded

1. Colorado River Union HSD#2 will promptly provide, arrange, and fund interim transportation for children in McKinney Vento as we collaborate with the all relevant stakeholders to institute a child's long-term transportation plan. Colorado River Union HSD#2 shall transport the student in the same manner as the rest of the students in the school district.
2. Interim transportation should be addressed to ensure that the student in McKinney Vento experiences no delays while transportation is being worked out between the parties.
3. If the McKinney Vento program is receiving transportation through another LEA program (i.e. the child's IEP states that they should receive transportation wherein that transportation is funded through the IDEA Act, etc.), then the student shall be transported through the stated program.
4. If the bus route needs to be altered to meet the needs of the child, the Colorado River Union HSD#2 will transport the child after modifying the bus route.
5. The Colorado River Union HSD#2 will ensure that children in McKinney Vento will promptly receive transportation to their school of origin in a cost-effective manner and in accordance with section 475(4)(A) of the Social Security Act (42 U.S.C. 675 (4)(A)). The Colorado River Union HSD#2 will include no or low-cost transportation options. In such event, the Colorado River Union HSD#2 will agree to pay for the cost of transportation and will pursue reimbursement from the local CWA for the cost of transportation. The Colorado River Union HSD#2 may seek a cost sharing agreement with the local CWA for the cost of transportation if appropriate, to determine methods of transportation to be used, when such methods would be used, as well as procedures to ensure student safety, etc.)
