**Turf Field:**

Reviewed recommendations of Shaw Turf and Field Turf to continue with crumb rubber replacement on the turf field. Organic infill is more expensive, requires more frequent replacement, and is not suitable for NH winter conditions. Ms. O'Blenes will review a University of Wisconsin study recommended by Dr. Manning.

**SAFE Grant Update:**

All activities have been encumbered, with one exception, all vendors have received PO's, and supplies are ordered. Dr. Arakelian extended highest compliments to everyone who worked on coordinating the applications and implementation of the SAFE Grant project to date.

**Crescent Lake PTO Donation:**

The Crescent Lake PTO has received a \$10,000 donation to purchase and install a shade structure on the playground.

**Magic Moments Playground:**

The Wolfeboro Area Children's Center received a large private donation to purchase and install a playground structure. The structure has been ordered and installation is expected in late fall.

**Carpenter Playground:**

A dumpster is scheduled for delivery; demolition of the old playground equipment is scheduled for the week of June 26<sup>th</sup>; the new playground structure is scheduled for delivery on August 18<sup>th</sup>; to be installed on August 26<sup>th</sup> and ready for use on September 5<sup>th</sup>.

Mr. Deshaies will review the RSA governing the School Board's approval of the use of and improvement to school property under these circumstances. The June 2022 meeting minutes will also be reviewed to confirm the language of the motion approving the playground replacement.

**Other Business:**

Water and electrical issue at the Alumni Field Snack Shack, safety improvements at the SAU building, and the KRHS clock were discussed.
