Consolidated School Improvement Plan ("CSIP")

- We have 4 areas in the CSIP that we need to consider.
- We have 5 goals for the 2017-2018 school year
 - Proficiency – This is determined by our EOC assessments
 - Students will achieve 65% proficiency on state tests in reading and mathematics.
 - Students will achieve 55% proficiency in science, 55% proficiency in social studies, and 62% proficiency in writing during the 2019-2010 school year.
 - Reading and Math are considered for Novice reduction and percentage proficient and distinguished (P/D)
 - Gap – Any student that is white and pays full price for lunch
 - This group will decrease the overall novice performance in math, reading, science, social studies, and writing by 15%.

- Graduation Rate – It will increase to 94% by the end of the 2019-2020 school year.
 - We met this rate last year.
 - This will be an increase from last year.

- Transition Readiness
 - Will reach 85% by 2019-2020 school year.
 - This will be obtained through academic-readiness, technical-readiness, or military-readiness.

- Equitable Access
 - It will decrease teacher turnover from 41.60% in 2016-2017 to 10% by 2019-2020.
 - This has been improved the past few years.
