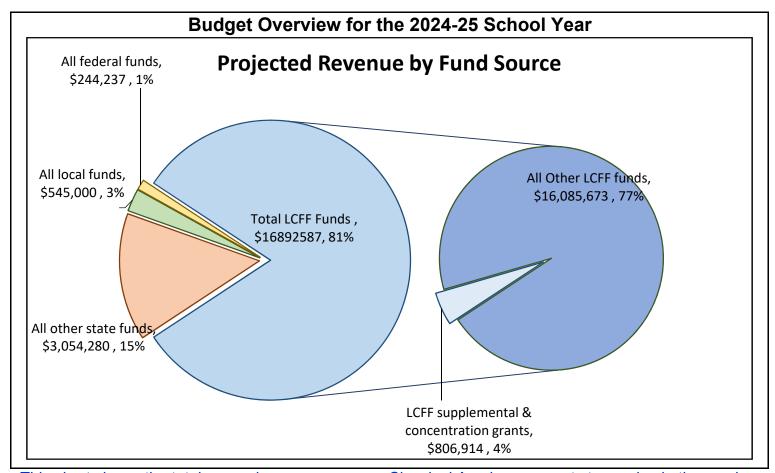

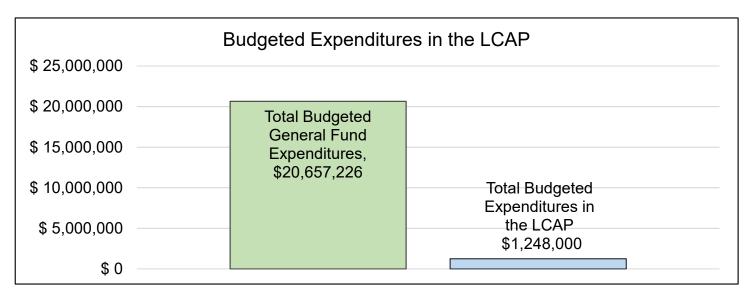

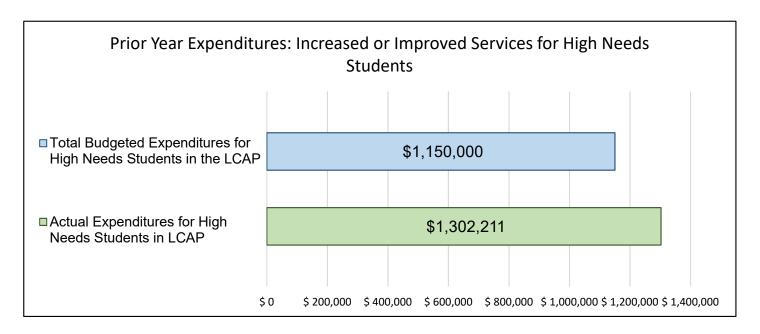

Despite initial setbacks, concerted data collection and analysis efforts revealed tangible academic gains over the years.

Specifically, in English Language Arts (ELA), 64 percent of students met or exceeded the standards, showcasing commendable proficiency. Additionally, 53 percent of students in mathematics met or exceeded the state standard, indicating substantial progress and achievement in the critical subject area. These outcomes affirm our commitment to fostering academic excellence and ensuring the preparedness of our students for the challenges of high school education.

Our plan remained steadfast in fostering student academic growth and proficiency for high school readiness. These figures underscore our commitment to nurturing a supportive environment where students feel connected, empowered, and equipped with the skills necessary for academic success.

We adhered closely to our outlined plan, making adjustments as needed to enhance student support. In the second year, recognizing increased emotional needs, we introduced a second counselor. Furthermore, we refined our student survey approach, concentrating on gathering feedback from 5th and 7th graders. These adaptations underscore our commitment to responsiveness and continuous improvement, ensuring our initiatives evolve in alignment with the evolving needs of our student community.

 - o This percentage is the total of the Planned Percentage of Improved Services column.
- Planned Percentage to Increase or Improve Services for the coming school year (4 divided by 1, plus 5)
 - o This percentage is calculated by dividing the Total Planned Contributing Expenditures (4) by the Projected LCFF Base Grant (1), converting the quotient to a percentage, and adding it to the Total Planned Percentage of Improved Services (5).

Contributing Actions Annual Update Table

• Difference Between Planned and Estimated Actual Percentage of Improved Services (Subtract 5 from 8)

o This amount is the Total Planned Percentage of Improved Services (5) subtracted from the Total Estimated Actual Percentage of Improved Services (8).

LCFF Carryover Table

- 10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 plus Carryover %)
 - o This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover Percentage from the prior year.
- 11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)

o This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).

• 12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)

o If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.
