



Grade-level teams met weekly during collaborative meetings to analyze student data in order to plan targeted interventions. Coastal Academy held Student Study Teams (SSTs) to determine actionable steps with the teacher and parents to support individual students' academic and/or behavior.

Coastal Academy provided a range of resources and support to enhance academic and social-emotional success. This included access to skilled specialists such as Specialized Academic Instructors, math and reading specialists, and intervention coordinators who tailored interventions, supplementary instruction methods, and specialized curriculum materials. Utilizing both formal and informal assessment data, Coastal Academy crafted individualized plans to deliver targeted instruction and interventions, ensuring students were equipped with the knowledge and skills needed to excel within the Common Core State Standards framework.

In addition, 100% of teachers were credentialed each year.

In addition, we had more parent engagement opportunities on our campus with group tours, new family orientations, C Track parent support, and onboarding presentations.

The success of students' social and emotional well-being stemmed from a variety of factors. These included personalized counseling sessions individually and in groups, consistent professional development opportunities, and implementing practices aimed at fostering a positive school environment through the Character Strong curriculum.

Firstly, our performance in English Language Arts (ELA) on the California Assessment of Student Performance and Progress (CAASPP) surpasses the state standard by an impressive 25 points. This achievement not only reflects the effectiveness of our ELA curriculum and instructional practices but also speaks to the hard work and dedication of our students and educators. Furthermore, our continued growth in ELA, with an 8-point increase in the 2022-2023 school year compared to the previous year, demonstrates our commitment to ongoing improvement and excellence in literacy education.

While our performance in Math on the CAASPP falls slightly below the state standard, it's important to note the significant progress we've made. In the 2022-2023 school year, Coastal Academy showed substantial improvement in Math, with a growth of 13.5 points compared to the prior year. This progress underscores our dedication to addressing areas of need and implementing effective strategies to support student learning and achievement in mathematics.

In addition to academic performance, our English Language Proficiency data from the English Language Proficiency Assessments for California (ELPAC) provides further insight into our school's success in supporting English Learners. With a reclassification rate of 47% and a majority of students demonstrating growth and proficiency on the ELPAC assessment, we are proud of the strides we've made in promoting English language development and ensuring equitable access to educational opportunities for all students.

As a school, this data is crucial as it allows us to assess our progress, identify areas for growth, and make informed decisions to better support the diverse needs of our student population. By analyzing our performance data, we can celebrate our successes, address challenges, and continuously strive towards our goal of providing a high-quality education that empowers every student to reach their full potential.
