RESOLUTION RELATING TO AMENDING RESOLUTION DESIGNATING COMBINED POLLING PLACES AND VOTING HOURS FOR SCHOOL DISTRICT ELECTIONS WHEN NO OTHER ELECTION IS BEING HELD IN THE SCHOOL DISTRICT

BE IT RESOLVED by the School Board (the Board) of Independent School District No. 833 (South Washington County Schools), Minnesota (the District), as follows:

1. By resolution duly adopted on December 15, 2022 entitled “RESOLUTION RELATING TO DESIGNATING COMBINED POLLING PLACES AND VOTING HOURS FOR SCHOOL DISTRICT ELECTIONS WHEN NO OTHER ELECTION IS BEING HELD IN THE SCHOOL DISTRICT” (the Original Resolution) this Board established combined polling places and voting hours for school district elections when no other election is being held in the District. It was subsequently discovered that the polling place locations had changed in District Precinct 8 and District Precinct 16 and that District Precinct 22 had been eliminated and its voters reassigned to District Precinct 21.

2. Accordingly, the following modification to the Original Resolution is necessary. The second paragraph of the Original Resolution shall be deleted in its entirety and the following substituted therefor:

2. Taking into account both geographical and population distribution, the Board hereby designates the following combined polling places, which are at locations designated for use as a polling place by the county or municipality, for use in District elections when no other election is being held in the District:
