1. **Get to know a Board Member:** Bob Lewis & Julia Sweeney
The Board heard from Business Representatives Bob Lewis and Julia Sweeney on their background and qualifications, why they wanted to join the Board and what they are excited about at CMP.
2. **Campus Reports:** Board members reviewed Campus Reports as submitted. CMP-Capitol presented and shared student & staff demographics, literacy opportunities, work around Diversity, Equity and Inclusion, the return of field trips, and the campus' focus on MTSS and PBIS. Principal Shannon Schmidt recognized her families and their incredible support, especially in the area of fundraising. CMP-Capitol is also looking at adding a portable, more play/sensory areas, and a new playground.

6. **CMP-Orangevale Modernization Project:** Superintendent Barley provided the Board with the draft phases and timelines for the CMP-Orangevale Modernization Project.
7. **Governing Board Updates:** Governing Board Secretary Carrie Klagenberg informed the Board of the CMP-Capitol and CMP-Shingle Springs Parent Representative Election results: Jenna Westbrook-Kline (CMP-Capitol) and Ann Curtis (CMP-Shingle Springs).  - Jenna Westbrook-Kline, CMP-Capitol, addressed the Board regarding the teacher payscale and asked the Board to postpone voting on the payscale to solicit additional feedback from the teachers.
 - Dr. Rainbow Porthe, CMP-Capitol, thanked the committee for their work and requested the Board to postpone the vote on the payscale to seek additional feedback from teachers and look into National Board Certification further.

2. Amendment to Carmichael Lease (Attachment #9)
