# YOU SCIENCE CAREER ASSESSMENT RESULTS FOR 10TH - 12TH GRADERS!

All sophomores took this <u>excellent career assessment</u> this fall in their Chemistry classes, and now have access to personalized career results and resources for 10 years! Current Juniors & Seniors took YouScience last year, and have access to their results for 9 more years.

YouScience (YS) is highly regarded as an assessment that measures students' personal strengths (as opposed to simply their interests). YS uses a series of "brain games" to assess students' skills in a variety of areas; it's fun, challenging and provides detailed and useful feedback for career & educational planning.

To see your student's results, go to the <u>YouScience log-in</u> <u>page</u> and enter the email (might be your APS GMail or personal email) and the password they set up when registering. If they don't remember, click "forgot password".

#### HOW DO THE BRIDGE & LOTTERY SCHOLARSHIPS WORK?

You may have heard that the Lottery Scholarship can only be used at public colleges, universities & trade schools in New Mexico: true! The funds actually come from the purchase of NM lottery tickets, and can only be used at public institutions of higher learning in our state.

What else is important to know about the Lottery? It doesn't require an application, and *it doesn't kick in until the SECOND semester of college!* To qualify for the Lottery, and keep it for up to 7 semesters, a

student must:

- Be a NM resident and graduate from an accredited NM high school
- Enroll in an approved NM college within 16 months of HS graduation
- Take (and pass!) at least 15 credit hours (at 4-year colleges) or 12 credit hours (at 2-year schools) in their first semester.\*

- Earn a 2.5 min. GPA in that first semester.
- That's it! No application. The college will notify the student that Lottery funds have been added to their account starting 2nd semester.

\*Exceptions may be granted to students with documented disabilities.

The "Bridge" stands for Bridge to Success, the name UNM & CNM give to their **1st-semester** scholarships for incoming Freshmen. Other colleges offer 1st-semester scholarships under different names (e.g., NMSU's Pete's **Opportunity Scholarship, NM Tech's Tech Tuition** Assistance). These 1stsemester scholarships are intended to help "bridge the gap" before the Lottery Scholarship kicks in 2nd semester. To qualify for a 1stsemester scholarship, students must:

• Be a NM resident & graduate from an accredited NM HS



- Enroll within 16 mos. of graduation at an approved NM college or university
- Have a minimum HS GPA-- determined by each college (currently 3.3 at UNM, 3.0 for NM State, no minimum for CNM or NM Tech).
- Meet the scholarship deadline set by each college.

#### What is the value of the Lottery?

- It <u>depends on the type of college/university</u>, and varies annually, as announced by the NM Legislature.
- The Lottery covers a *percentage of tuition* (and, in the case of CNM, mandatory student **fees**) each semester for up to 7 semesters.
- At UNM (a 4-year research university), the Lottery is currently valued at \$3,444.06/semester. UNM's cost of tuition & fees for 15 credit hours (1 f/t semester) is currently \$4,614. Therefore, at UNM the Lottery currently covers ~ 75% of tuition & fees.
- At CNM, a 2-year community college, the Lottery typically covers a larger % of the cost of tuition + fees for each semester.
- Did you know? Students can earn an Associate's Degree at CNM, where the Bridge (1st semester) & Lottery Scholarships (2nd through 4th semesters) cover almost all of the cost, then transfer to one of NM's 4-year colleges to complete their Bachelor's degree... and still have 4 semesters of the Lottery coming to them!

#### What Should Juniors Be Doing This Year to Prepare for College?

Junior year presents an excellent opportunity to gather information on potential postsecondary plans (college, military, trades, apprenticeships...) and careers that might be a good fit for students. The EHS Counseling website offers pages devoted to college resources, career resources, trades & apprenticeships, financial aid & scholarships, and much more. Ms. Velhagen has posted short videos about college & career topics. Juniors should become familiar with these resources and spend time doing their own research and soulsearching.

During COVID, most colleges have posted virtual tours on their websites; it's important for students to get a feel for the campuses where they're considering spending 4 years of their life! Juniors should get involved in activities and work toward roles of leadership, if possible. Colleges and scholarship agencies like to see extracurricular interest, community/school involvement, passion and leadership. Check out Eldorado's diverse clubs & activities, start your own, or find something in the community you're interested in and devote your time! Juniors should continue to do their best academically. **College** application deadlines may be as early as next fall, so think about what your transcript/GPA/class rank will look like at the end of this year, which is what colleges will be asking for!

#### FREE FIRST YEAR OF COLLEGE AT NM UNIVERSITIES! \*dependent on family income\*

The University of NM's Lobo First Year Promise covers the full cost of tuition & fees for the first year, for students with a family income of \$50K or less. Requires FAFSA or <u>NM State Aid application</u> (for students w/o SSN).

New Mexico Tech has announced the First Year Student Success Scholarship : covers tuition + fees for students who are Pell Grant eligible (as determined by the FAFSA).

#### FAFSA: Why fill it out, and when?

- HS seniors fill out <u>Free Application</u> <u>for Federal Student Aid</u> to potentially qualify for government financial aid in the forms of <u>grants</u>, <u>scholarships</u>, <u>work-study jobs and</u> <u>low-interest-rate subsidized loans</u>. FAFSA also goes to the financial aid office of each college the student lists; colleges then have a sense of the family's income and can assess whether they're able to offer additional financial aid.
- Even if you're confident your student is unlikely to qualify for federal assistance, don't assume you should skip FAFSA!

- The college(s) of your choice may REQUIRE the FAFSA for academic scholarships, not just need-based. (Be sure to check!)
- Students fill out the FAFSA, with updated taxes from 2 years prior, every year they're in college. FAFSA opens on October 1 annually. Fill it out ASAP and watch for deadlines:
- NAU Priority Deadline: 11/15/21
- UNM Priority Deadline: 1/5/22
- ASU Priority Deadline: 1/15/22
- NMSU Priority Deadline: 3/1/22
- NM Tech Priority Deadline: 3/1/22
- TX Tech Priority Deadline: 3/1/22
- CNM Priority Deadline: 5/1/22
