



These charts show the total general purpose revenue California Montessori Project - Elk Grove Campus expects to receive in the coming year from all sources.

The total revenue projected for California Montessori Project - Elk Grove Campus is \$7,624,554, of which \$5,877,974 is Local Control Funding Formula (LCFF), \$1,073,679 is other state funds, \$386,384 is local funds, and \$286,517 is federal funds. Of the \$5,877,974 in LCFF Funds, \$261,646 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

The LCFF gives school districts more flexibility in deciding how to use state funds. In exchange, school districts must work with parents, educators, students, and the community to develop a Local Control and Accountability Plan (LCAP) that shows how they will use these funds to serve students.

California Montessori Project - Elk Grove Campus plans to spend \$7,304,183 for the 2023-24 school year. In 2022-23, California Montessori Project - Elk Grove Campus's LCAP budgeted \$495,000 for planned actions to increase or improve services for high needs students. California Montessori Project - Elk Grove Campus actually spent \$403,617 for actions to increase or improve services for high needs students in 2022-23. The difference between the budgeted and estimated actual expenditures of \$91,383 had the following impact on California Montessori Project - Elk Grove Campus's ability to increase or improve services for high needs students:

# Plan Summary 2023-24

#### **General Information**

A description of the LEA, its schools, and its students in grades transitional kindergarten–12, as applicable to the LEA.

The Mission of the California Montessori Project is to offer a quality, tuition-free Montessori Education that challenges our students to reach their full potential.

The Vision of the California Montessori Project is to provide a Montessori education that supports the intellectual, social and emotional development of every child. This will be achieved by:

- \* Promoting independence
- \* Teaching respect for oneself and others
- \* Building confidence
- \* Creating a sense of social responsibility, and
- \* Empowering every student to be a global citizen.

CMP offers an environment which has the programs, resources and school climate to enable students to become educated to high academic standards and to develop themselves to their fullest capacity as competent, happy, productive individuals, family members, workers, and contributors to a better society and a peaceful world.

This mission is achieved through the dedication and commitment of the CMP Learning Community: parents, teachers, community groups, the legislature, CMP Governing Board, Campus Advisory Committee (CAC), and, most importantly, the individual child.

CMP is committed to small class size, highly-qualified Teaching Assistants and highly-qualified, dual-

certified Teachers (California Teacher Credential and age appropriate Montessori Certification) in every class.

The CMP-Elk Grove Campus is comprised of two sites. The original facility located on Elk Grove Blvd is a former public school campus leased through the Cosumnes Community Services District. The facility houses an office and six traditional classrooms. This site serves students in Transitional Kindergarten thru 3rd grade. The school grounds include a spacious field, a playground, and a large asphalt play area with a basketball court. The second facility is located just 2.2 miles from the original site on Bradshaw Road. Ten acres of land houses school offices, 16 classrooms, a library/Club M room, Learning Center and a large multipurpose room. This site serves students in Transitional Kindergarten thru 8th grade. The school grounds include a separate Kindergarten play area, a large asphalt play area, and a large play field. Custodial and maintenance services are provided in the late afternoon and evening through contractual services and parent volunteers.

CMP-Elk Grove Campus serves students in Transitional Kindergarten through Eighth Grade. As a public charter school, there is an open enrollment policy.

#### **Reflections: Successes**

California Montessori Project (CMP) saw some great success with overall academics. While the state and CMP's authorizing districts saw a decline in Math and English Language Arts test scores, CMP saw increases in both areas. CMP credits this success to the renewed attention to offering a Montessori education aligned with CA state standards and strong instructional practices.

CMP also went through the process of re-establishing the Positive Behavioral Inverventions and Supports system (an evidence-based framework for supporting students' behavioral, academic, social, emotional and mental health needs).

CMP partnered with Sacramento State University for professional development in diversity, equity and inclusion training. This resulted in the drafting of a network-wide 'Acceptance, Belonging and Care' Statement.

CMP rolled out a new, evidence-based, Tier 1, Science of Reading early literacy program. This program has already shown strong results in its first year of implementation.

#### **Reflections: Identified Need**

Under the Every Student Succeeds Act (ESSA), CMP-Elk Grove qualified for Additional Targeted Support Identification (ATSI) using Criteria 2: Schools with a student group(s) with all indicators at the lowest status level but one indicator at another status level. The ATSI qualification is based on indicator results shown on the CA School Dashboard.

At CMP-Elk Grove, the 'Students with Disabilities' student group showed the following results on the CA School Dashboard:

- \* Chronic Absenteeism Very High
- \* Suspension Medium
- \* Academic English Language Arts Very Low
- \* Academic Math Very Low

CMP will provide additional supports to the 'Students with Disability' student group, particularly surrounding absenteeism, English-Language Arts (ELA) and Math.

Academics: CMP-Elk Grove scored "Very Low" in ELA and Math for the "Students with Disabilities" student group on the Dashboard. CMP will continue the work we started this past year to offer stronger Tier 1 instruction in ELA and Math. Last year an evidence based, "Science of Reading" early literacy program was implemented in Transitional Kindergarten-3rd Grade. It is expected that program will result in more students performing above standard in ELA in future years. Last year, CMP also piloted a new math rotation model in Upper Elementary at one of its schools that proved to be a best practice. It is intended that this practice will be brought to the CMP-Elk Grove school and expand some of the lessons learned to lower elementary and Middle School. CMP-Elk Grove will also have a Reading Specialist and a Math Specialist next year that will support Tier 2 instruction for students in need.

While the whole school population at CMP saw growth in English Language Arts (ELA) and Math, there is still significant room to improve. CMP will seek growth in ELA and Math through a more defined instructional practice. CMP will seek further improvement with continued work with a dedicated math committee, focus on early literacy and a commitment to continue with high-quality "Tier 1" instruction.

Chronic Absenteeism: All students had higher than usual chronic absenteeism rates than they have had historically. This is attributable to the effects of the pandemic, the requirement to isolate and quarantine, and families being more cautious about sending students to school with cold symptoms. CMP plans to conduct a robust student attendance campaign to encourage stronger student attendance during school year 23/24.

Suspension: CMP-Elk Grove had a "medium" suspension rate, 2.1%, for the student group "Students with Disabilities". CMP-Elk Grove intends to continue with the efforts to restore the schoolwide Positive Behavior and Intervention Support system, build upon efforts this year to implement more robust restorative practices, and more deeply integrate the social emotional curriculum into classroom practices.

While CMP's suspension rate is not high, there is also room for improvement in this area. CMP will provide attention here through a Positive Behavioral Interventions and Supports (PBIS) approach, which is an evidence-based framework for supporting students' behavioral, academic, social, emotionial and mental health needs, and with a focus on restorative justice practices.

# **Engaging Educational Partners**

The California Montessori Project - Elk Grove Campus has provided numerous opportunities for stakeholder engagement, as part of the greater California Montessori Project (CMP), as well as an individual charter school within the Elk Grove Unified School District (EGUSD). Members of the CMP Learning Community, as well as the public-at-large, have been invited to attend monthly meetings of the CMP Governing Board, and to provide input regarding the creation and implementation of the Strategic Plan and Local Control Accountability Plans (LCAP). During the months of April and May, CMP's Superintendent, Brett Barley, met with 4 distinct groups of educational partners at each site, to receive input. Members of the community (including parent/guardians, credentialed staff, classified staff and students) were invited to meetings where the LCAP, and Strategic Plan goals and action steps were shared. Educational Partners were asked to help prioritize goals for the following year. Following the meeting, a survey was sent to Educational Partners giving an additional opportunity to provide input.

Input from the Educational Partner meetings and the survey input was reviewed for common threads. Considerations of fiscal impact and timeline were considered when reviewing this input. This input contributed to the Strategic Plan and the LCAP Plan.

Under the Every Student Succeeds Act (ESSA), CMP-Elk Grove qualified for Additional Targeted Support Identification (ATSI) using Criteria 2: Schools with a student group(s) with all indicators at the lowest status level but one indicator at another status level. The ATSI qualification is based on indicator results shown on the CA School Dashboard.

At CMP-Elk Grove, the 'Students with Disabilities' student group showed the following results on the CA School Dashboard:

During the Educational Partner meetings, this information was shared and feeback was requested on how to serve the 'Students with Disabilities' student group.

Survey respondents encouraged CMP to continue focus on:

\* All classrooms have full complement of Montessori materials.

\* Maintain a low student to teacher ratio. Commit to maintaining a Credentialed, Montessori Trained teacher as well as a trained Teaching Assistant in every classroom, lowering the overall student to adult ratio. Provide all Teaching Assistants opportunities to become Montessori trained.

\* Continue to ensure all students have access to a well-rounded education during the traditional school day, including physical education and engaging, standards-aligned field trips.

\* Research and expand best practices for student leadership opportunities in all grade levels.

\* Hire Math Intervention Teachers and develop additional math support staff to support math interventions at all campuses.

\* Maintain English Language Arts Intervention Teachers and develop additional reading and writing support staff to support interventions at all campuses.

\* Provide cultural competency and responsive teaching, diversity, equity, implicit bias and inclusion Professional Development to all staff to support a diverse population of students.

\* Continue to support Montessori Training for Teachers and Teaching Assistants.

\* Professional Development Plans and processes will be reviewed to ensure Montessori and California standards aligned instructional practices are evaluated.

\* Conduct a survey of the needs of all instructional staff for input into the professional development offered, to determine concentrated and targeted needs and will align professional development for instructional staff to academic targets.

The input from CMP stakeholders from this LCAP season helped refine the goals and actions in the Strategic Plan and the LCAP. Some of this work included:

\* Continued support for Montessori Training for teachers.

- \* Dedicated PE Teacher(s) at each campus
- \* Fieldtrips occurring at each grade level
- \* Growing CMP's Music, Visual and Performing Arts offerings.

\* Each classroom has a full complement of Montessori materials, and a process to replenish materials if they are broken and/or depleted

\* Math Committee formed and committee members trained colleagues on GLEAM (Grade-Level, Engaging, Affirming, and Meaningful) Instruction

\* SIPPS (Systematic Instruction in Phonological Awareness, Phonics, and Sight Words)/Heggerty training to staff and lessons to students in lower elementary; partnered with CORE to implement evidence based early literacy programing; offered Sonday, Wilson, and Barton for students in need; dyslexia program established

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.

## 13. LCFF Carryover — Percentage (12 divided by 9)

• This percentage is the unmet portion of the Percentage to Increase or Improve Services that the LEA must carry over into the coming LCAP year. The percentage is calculated by dividing the LCFF Carryover (12) by the LCFF Funding (9).
