The board's job is to assure that the Superintendent is following policies, procedures, and hiring the best people. The system is not broken, we have a great school. We have checks and balance to correct staff not doing a good job.
- KV: Told today (5/8) past Board members received additional information on new hires prior to meetings. It was a misunderstanding that the Board did not want that information. In future, she is requesting more information.
- JW: New hire information is confidential and we have to only provide what is legal. We will put more information in the Board packets and can adjust accordingly.
- KD: Addressed RD, now that the check and balances are completed, you still want more clarification that the individual is competent based on the hiring process.
- RD: Not enough information was provided, expected to vote yes and move on.
- JC: The Board ratifies new hires, they do not approve.
- RD: How does the Board ratify procedure changes? Asking for references, resumes, number of applicants, etc. for check and balances. This is not an attack on the HR department. Somewhere along the way, the Board was expected to vote on new hires. Not comfortable voting on new hires until there is a new procedure in place.
- RD: The procedure has been raised in several workshops about receiving more information on new hires. Why isn't it offered before now? The board's vote is meaningless.




