Monday-Thursday:



Long sleeve or short sleeve

polo in navy blue, light blue, white or grey.

Polos must have the registered trademark NVCA logo on it. Shirts must be purchased from an approved school vendor.

Navy blue or khaki pants or shorts. Girls may wear navy blue, khaki or NVCA plaid skirts or jumpers. Shorts and skirts must be knee-length. Shorts, leggings or tights should be worn under skirts.

Closed-toe and closed-heel shoes.

Sweatshirts and all outerwear in navy blue, light blue, grey or white and can be plain, have a small logo (smaller than a credit card) or the registered trademark NVCA logo on it. An NVCA polo must be worn underneath.

Friday:

Monday-Thursday attire permitted on Fridays as well

Friday tshirts or NVCA trademarked tshirts in navy blue, light blue, white or grey.

Monday-Friday:



Long sleeve or short sleeve polo or NVCA trademarked tshirts in navy blue, light blue, white or grey. All shirts must have the registered trademark NVCA logo or NVCA branding on it. Shirts must be purchased from an approved school vendor or been received through a school related event.

Navy blue, khaki or jean pants or shorts. Girls may wear navy blue, khaki or NVCA plaid skirts. Shorts must be mid-thigh and skirts must be knee-length.

Closed-toe shoes (Crocs are allowed)

Sweatshirts and all outerwear in navy blue, light blue, grey or white and can be plain, have a small logo (smaller than a credit card) or the registered trademark NVCA logo on it. Zip-up sweatshirts must have a NVCA trademarked polo underneath.
