06-19-PH01 **PURPOSE OF HEARING**

Under Indiana Law whenever a school corporation proposes to construct or renovate a school building at a cost in excess of one million dollars it must first hold a public meeting.

All interested parties may give testimony and/or ask questions concerning the (i) renovation of and improvements to the Central Campus, including Elementary and Middle School and Administration facilities, site work, and the purchase or equipment and technology (the “Central Campus Project”); and (ii) renovation of and improvements to the High School, including site work and the purchase of equipment and technology (the “High School Project,” which collectively with the Central Campus Project shall be referred to as the “Projects”)

The purpose of the hearing is two-fold: (1) to inform the public as to the proposed Projects; and (2) to allow all interested parties, taxpayers and patrons of the School Corporation to voice their opinions as the Projects and ask any questions.
