Reconfirm instructional delivery method:

Berrien RESA programs will be offered either In-Person or through Remote Learning.

Reconfirm how instruction will be delivered for each program:

ASD	Berrien RESA ASD programing offers both in-person learning and remote learning opportunities for students. For the weeks of 5/3 through 6/4 there was an average of 15 students participating in remote instruction and 61 participating in face to face instruction per week.
BLC	Berrien RESA Blossomland Learning Center programing offers both in-person learning and remote learning opportunities for students. For the weeks of 5/3 through 6/4 there was an average of 44 students participating in remote instruction and 134 participating in face to face instruction per week.
LEC	Berrien RESA LEC programing offers both in-person learning and remote learning opportunities for students. For the weeks of 5/3 through 6/4 there was an average of 10 students participating in remote instruction and 45 participating in face to face instruction per week.

Reconfirm whether or not the district is offering higher levels of in-person instruction for English language learners, special education students, or other special populations:

All Berrien RESA programs work with students with disabilities. Blossomland Learning Center is for students with moderate to severe cognitive impairments. Lighthouse Education Center is for students with severe emotional impairments. The ASD programs work with students with Autism Spectrum Disorder.
