Careful attention has been given to the alignment of our SUIP with TSD's Strive 2025 Strategic Plan. There were no questions from SAC. The staff provided input during LSWed this week and suggestions will be taken forward to the Leadership Team for discussion and final recommendations.</p> <p><u>CMAS Data:</u> Reviewed and discussed data trends, including sub-population data.</p> <p><u>Major Improvement Strategies:</u> At this time, the two Major Improvement Strategies (MIS) Ponderosa is considering will center on 1) Evidence-Based Instruction, and 2) Social Emotional Learning (SEL). Action Steps (what we will do) and Implementation Benchmarks (how we will measure it) are still being drafted with Leadership Team input and recommendations.</p> <p><u>Late Start Wednesdays:</u> Our Late Start Wednesday (LSWed) calendar has been drafted to meet the professional development needs of our SUIP and other major school initiatives. The school Leadership Team will review and approve a working draft calendar at their next Leadership Team meeting.</p>

<p>School Safety</p> <ul style="list-style-type: none"> • Single Access Entry • New screening requirements • Safe2Tell • Crisis Team • Health & Wellness Team 	<p>SAC discussed the following school safety features that are currently in place at Ponderosa:</p> <ul style="list-style-type: none"> - Monthly Emergency Drills are conducted with staff and students - Visitors must enter through front doors only for single-access entry - Screening for Visitors and Volunteers - Safe2Tell for anonymous reporting available and information on school and district websites - Health & Wellness Team is focusing on both physical and emotional well-being <p>A question about the single-access entry for after school hours was addressed (typically not needed as students are not in school). A discussion about large community events and the need for extra supervision during those events was held and the committee felt that the school was addressing the safety needs of students during those events. No major safety concerns were brought forward at this time.</p>
