9. SUPERINTENDENT'S REPORT

A. State Education News – Budget Update

Dr. Morana provided a budget update that included the amount of the reduction in state aid that was far greater than anticipated. While districts were told to plan for a 5 to 15 percent reduction in state aid, the Governor reduced state aid based on 5 percent of the total budget. For the district this meant a state aid reduction in the amount of \$755,000. Dr. Morana explained that the focus on the budget for 2010-2011 has been on the educational program for all of our students and that the Board, along with being cognizant with the reality of the loss of state aid for the district, has supported this. The positive news is that the Preschool funding has been expanded.

Dr. Morana reviewed the process to complete the budget, which includes voluntary salary freezes for the superintendent, business administrator, principals, and supervisors. The district is also freezing the salaries of non represented staff members. She then went over the list of cuts required to finalize the budget.

Dr. Morana indicated that she continues to advocate for the district through legislatures and the commissioner of education. (copy of presentation in Board Book)
