## FEDERAL STUDENT AID REFUND POLICY:

**If a student receiving Financial Aid withdraws from Great Plains Technology Center, they are subject to the Return of Title IV (R2T4) Funds policy, in accordance to Sec. 668.22 of the Federal Register. Great Plains Financial Aid office will complete the R2T4 to determine the amount of Financial Aid the student has earned for the time they were enrolled. If a student does not complete 60% or more of their payment period they will be required to return a portion of the funds disbursed. If a refund is due, the student will be notified of the amount due and date it is due.**

## SATISFACTORY PROGRESS INFORMATION

In order to receive Title IV and institutional assistance, a student must be in good standing and making satisfactory academic progress at this institution.

**Quantitative Measure** - At the time of review (after the each payment period) if it is determined that the student has not completed at least 67% of the course work assigned to the hours, then the student is not making SAP and will be placed on Financial Aid Warning.

**Pace of Progression** - The student is encouraged to complete the hours in the Career Major within the time projected. When extenuating circumstances exist, the projected time allowed can be extended to 1.5 times the number of weeks required to complete the Career Major. For example, the Career Major may have 1050 clock hours and 36 weeks. A student will have up to 54 weeks to complete the 1050 clock hours. The student is only eligible for financial aid for the 1050 hours of that Career Major and will not be paid extra for the extended weeks. In addition the student must complete the coursework associated with the hours to maintain SAP. If a student must repeat a course, the course hours are not eligible for financial aid and will count towards the 150% of class time to complete the Career Major.

**Qualitative Measure** - Upon completion of the payment period, the recipient must earn at least a 'C' average throughout the pursuit of the educational goals in the Career Major. An acceptable grade must be determined before the next payment can be issued. If a student does not complete a course within his/her Career Major, an incomplete grade is not given. The student must finish the course in order to receive a grade.

**Disbursement Rule** - The student must complete 100% of all course work within the payment period to be eligible for the next disbursement.
