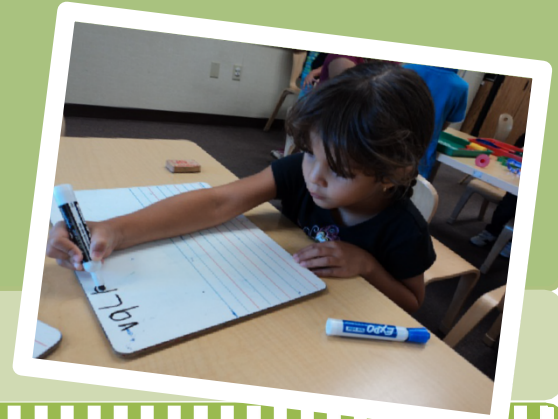

## **REQUIRED FORMS AND DOCUMENTATION FOR ALL STUDENTS** *FORMAS Y DOCUMENTOS REQUERIDOS PARA TODOS LOS ESTUDIANTES*

PARENT/GUARDIAN PARTICIPATION IS ENCOURAGED IN THE PRESCHOOL PROGRAM THROUGH THE SCHOOL YEAR.

1. Birth records for all children under 18 years of age in the family.  
*Actas de nacimiento o substitutos de todos los hermanos(as) menores de 18 años en la familia.*
2. Proof of address (any evidence of street address, e.g. utility bills, lease, etc.).  
*Comprobante de domicilio (Por ejemplo, recibos de utilidad, renta, etc.).*
3. Physician's Report (LIC 701 Form) - exam conducted within 1 year prior to enrollment date.  
*Examen físico (Forma LIC 701) que no exceda 1 año de haber sido administrado.*
4. Child's immunization record (must be up-to-date).  
*Registro o información de vacunas del niño(a) (debe estar actualizado).*
5. Proof of all family countable income for the two months previous to enrollment (e.g. paystubs, unemployment benefits, proof of child support, etc.).  
*Presentar todos los comprobantes de ingresos familiares contables de los dos meses anteriores a la fecha de inscripción (Por ejemplo: talones de cheque, beneficios de desempleo, manutención de hijos, etc.).*
