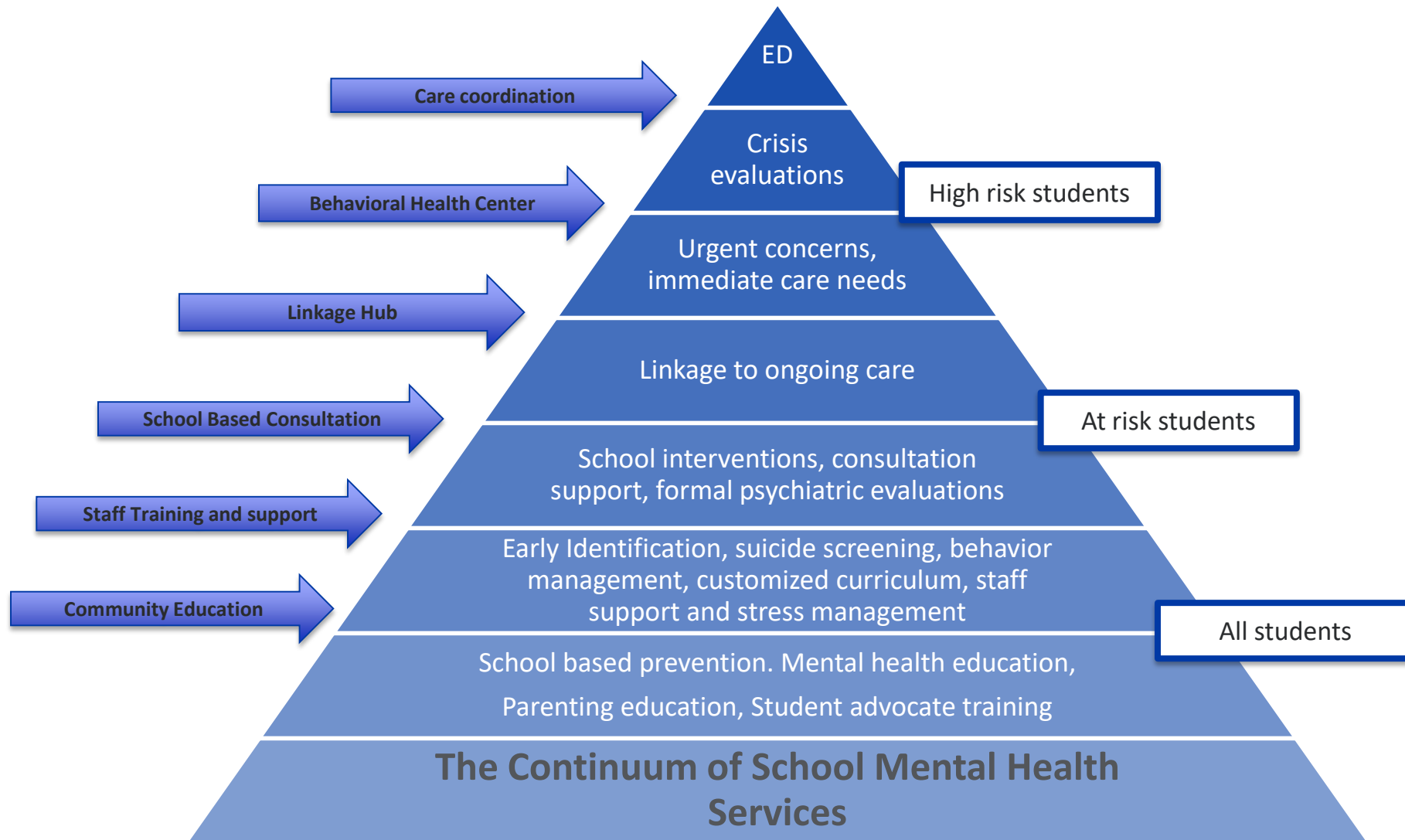

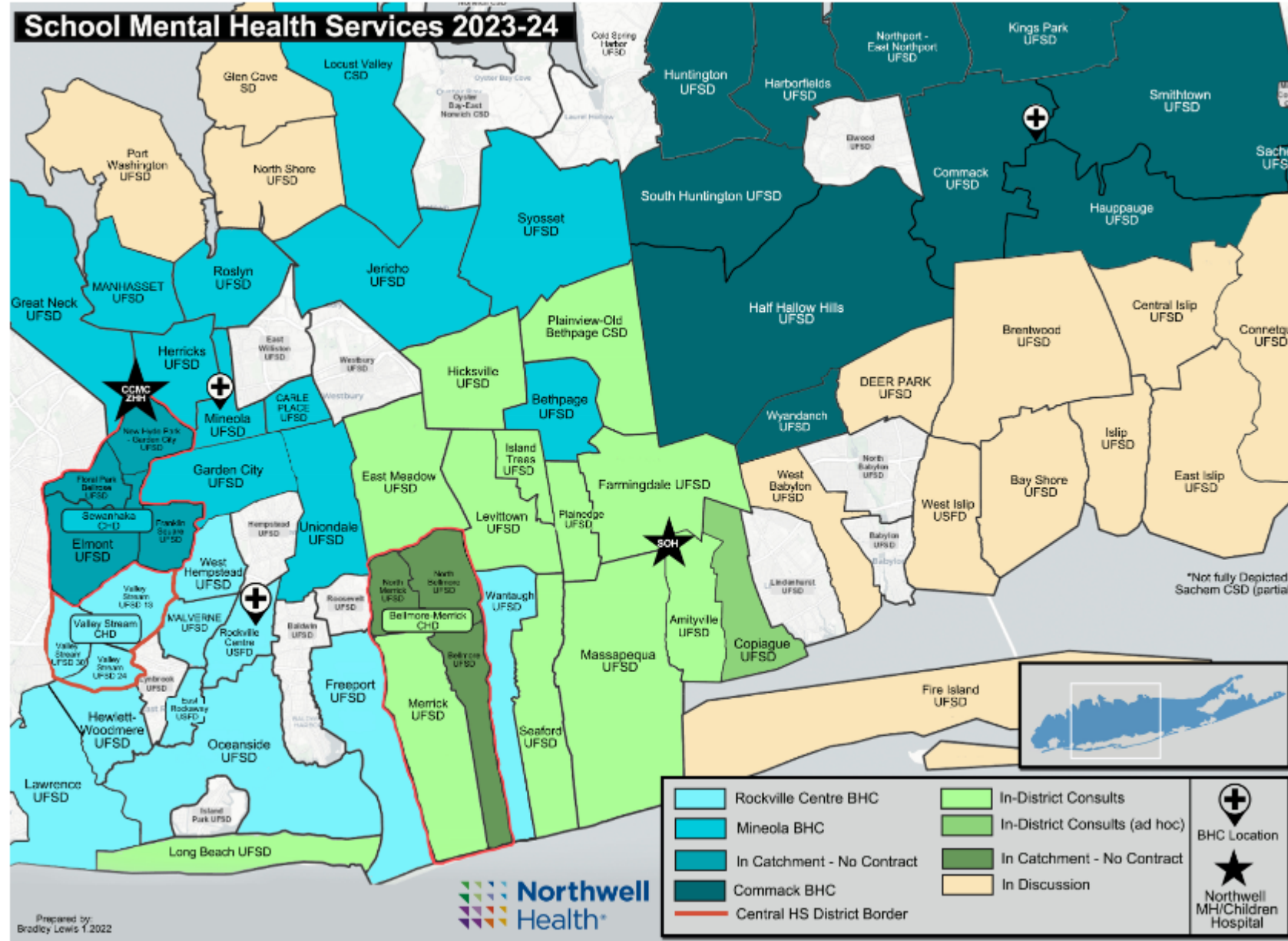

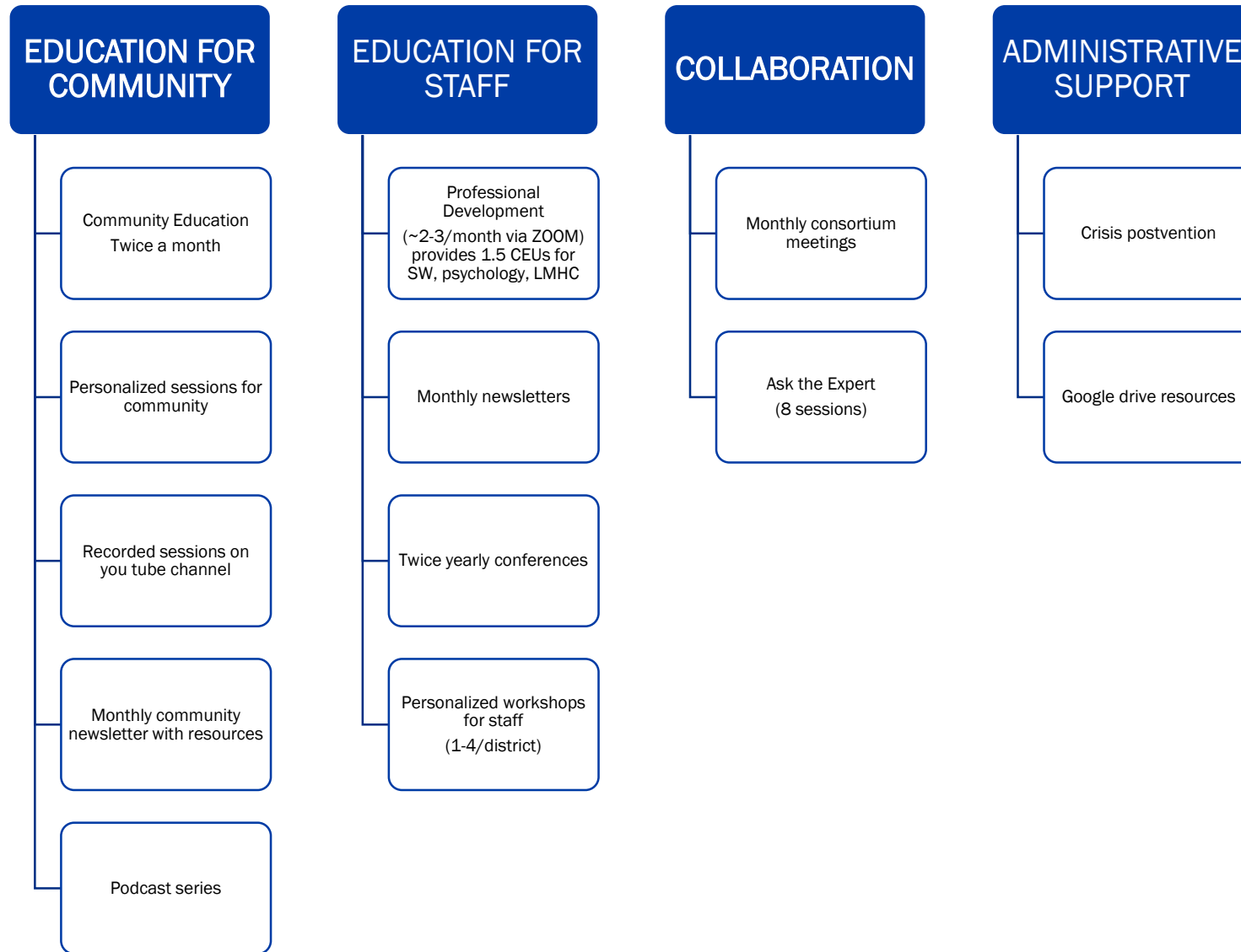

The content provided in each education session is presented in explicit detail, consistent with trainings provided to clinical professionals in the healthcare industry. We will discuss and identify the best approach to supporting individual students in need, both in the school environment and through connections to the appropriate level of care. We will provide postvention support and help school districts manage critical incidents in their community.
