

# **Morning & Afternoon Extended Day Enrichment**

Are you currently operating an extended day program? Does your district wish to start a program?

Take advantage of an opportunity to give your students the benefit of an extended day program in their school. The program includes STEAM-based (Science, Technology, Engineering, Art and Mathematics) enrichment opportunities combined with homework assistance and is run by Eastern Suffolk BOCES under the supervision of an ESBOCES appointed director and staff. The district can choose the extended day hours and locations. Current programs operate:

Before school from 7:00 a.m. to the start of schoolAfter school from dismissal to 6:00 p.m.

### **Additional Information:**

✓ Students will receive afternoon homework support where they will be provided with direct assistance for their daily assignments by a certified teacher.

 ✓ The program provides refreshments each afternoon consisting of a nutritious snack and milk or juice for each student.

✓ Students are provided time for structured recreation in the morning and afternoon programs. Typical recreational activities available include: use of the school's gymnasium, use of available technology, such as SMART Boards to provide interactive studentcentered "virtual learning" experiences, and use of the school's playgrounds.

 ✓ During the course of the year, special enrichment courses and Arts-in Education presentations will be made available for students to participate in.

 Daily themed enrichment activities and social and emotional learning lessons (SEL) are offered for all students to participate in.

 $\checkmark$  Transportation to and from the programs is the responsibility of parents and guardians.
