#### WELCOME TO THE 2023/2024 SCHOOL YEAR!

Lakewood Food Service uses Quik Lunch, a point-of-sale system, to record your child's lunch payments. Each student is given an identification number (PIN number) when they enroll. Students in grades 3-12 are required to memorize their PIN number and enter it into a keypad each day. Students may make deposits into their accounts at any time. The price for a lunch at Lakewood is \$3.00 per day for full pay students, \$.40 a day for reduced price students and those approved for free meals will receive FREE meals. Breakfast is \$1.50 for FULL PAY STUDENTS and FREE to free and reduced priced meal students. Parents may make payments by cash, check or money order. Please make checks payable to Lakewood Food Service.

Payments can also be made via the internet. You may access the online payment website by going to our district website at: www.lakewoodlocal.k12.oh.us

Click on the Payforit logo to be transferred to their payment site., or go to <a href="www.payforit.net">www.payforit.net</a> You will be asked to register and create a password. Next, add your child's name and ID number. Once this process is complete, you may manage your child's account from the convenience of your home or office. Payments made online will be credited within a couple of hours. Additionally, a "Low-Lunch" balance e-mail will be sent when your balance reaches the price of a single lunch (In most cases \$3.00). Lastly, please be sure to allow Payforit into your e-mail box—otherwise it may be considered spam and go into your junk e-mail.

Your child may qualify for free or reduced-priced lunches. If you think your child qualifies, please fill out an application and return it to your child's school. YOU SHOULD ONLY FILL OUT ONE APPLICATION PER HOUSEHOLD. You may fill out a lunch application online by visiting: <a href="https://www.lakewoodlocal.k12.oh.us">www.lakewoodlocal.k12.oh.us</a> and then click on the PAYSCHOOLS icon

Online applications are private and secure. If you are new to the district and your child received free or reduced lunches at their previous school, you will need to fill out a new form and wait for it to be processed before your child receives free or reduced lunches at Lakewood. Please make sure your child has lunch money in their account until you receive notice from the food service department regarding your child's status.

LAKEWOOD ELEMENTARY: Students in grades K-2 must drop their lunch deposits into a folder, which is located in the student's homeroom. The deposits must be put into individual baggies or envelopes and labeled with the student's name and PIN number. Please note: No payments will be taken during the lunch line. Students may charge lunch in Emergency cases only up to 3 meals.

JACKSON INTERMEDIATE SCHOOL: Students in grades 3-5 must drop their lunch deposits into a folder, which is located in the student's homeroom. The deposits must be put into individual envelopes and labeled with the student's name and PIN number. Please note: No payments will be taken during the lunch line. Students may charge lunch in Emergency cases only up to 3 meals.

**LAKEWOOD MIDDLE SCHOOL:** Students in grades 6-8 should make their lunch deposits in the cafeteria before classes start in the morning. A deposit box is located in the cafeteria and students should put their deposits into the envelopes provided with their name and PIN number on the outside of the envelope. Please note: No payments will be taken during the lunch line. Students may charge lunch in  $Emergency\ cases\ only\ up\ to\ 3\ meals.$ 

LAKEWOOD HIGH SCHOOL: Students in grades 9-12 may visit the cafeteria cashier in the morning during breakfast to make deposits to their accounts. Students are also welcome to pay cash during lunch, but please note that we do not give change to any student at any time. All monies given to the cashier at LHS and LMS will be applied to the student's account. Students may charge lunch in Emergency cases only up to 3 meals.

A Red Questions About Free and Reduced-Price School Meals

#### Dear Parent/Guardian:

Children need healthy meals to learn. The LAKEWOOD LOCAL SCHOOLS offers healthy meals each school day. Breakfast costs \$1.50 and lunch costs \$3.00. Your children may qualify for free meals or for reduced-price meals. Reduced price is \$.30 for breakfast and \$.40 for lunch. This packet includes an application for free or reduced-price meal benefits and detailed instructions. Below are some common questions and answers to help you with the application process.

1. Who can receive free or reduced-price meals? All children in households receiving benefits from the Supplemental Nutrition Assistance Program (SNAP) or Ohio Works First (OWF); foster children that are under the legal responsibility of a foster care agency or court; children participating in their school's Head Start program; and children who meet the definition of homeless, runaway, or migrant are eligible for free meals. Also, your children may receive free or reduced-price meals if your household's income is within the federal income eligibility guidelines limits.

- 2. How do I know if my children qualify as homeless, migrant or runaway? If members of your household lack a permanent address; are staying together in a shelter, hotel or other temporary housing arrangement; relocate on a seasonal basis or; children live with you who have chosen to leave their prior family or household then the children may qualify as homeless, migrant or runaway. If you have not been told your children will receive free meals, please call or email JENNIFER STOVER at JSTOVER@LAKEWOODLOCAL.K12.OH.US or call 740-928-4526 ext.5017 to see if they qualify.
- 3. Do I need to fill out an application for each child? No. Use one free and reduced-price school meal application for all students in your household. We cannot approve an application that is not complete. Please submit all required information. Return the completed application to your child's school or to JENNIFER STOVER at JSTOVER@LAKEWOODLOCAL.K12.OH.US or mail to P.O. BOX 70, Hebron, Ohio 43025
- 4. Should I complete an application if I received a letter this school year saying my children are approved already for free meals? No, but please read the letter carefully and follow the instructions. If any children in your household were missing from the eligibility notification, contact JENNIFER STOVER at 740-928-4526 ext.5017 or JSTOVER@LAKEWOODLOCAL.K12.OH.US
- 5. Can I apply online? Yes. If possible, you are encouraged to complete an online application instead of a paper application. The online application requirements are the same and will request the same information as the paper application. #### Our Mission:

- 6. My child's application was approved last year. Do I need to complete another application? Yes. Your child's application is valid for that school year and for the start of this school year. You are required to submit a new application unless the school notified you that your child is eligible for the new school year.
- I receive Women, Infants and Children (WIC) benefits. Can my child(ren) get free meals? Children in households participating in WIC may be eligible for free or reduced-price meals. Please submit a completed application.
- 8. Will the information I give be checked? Yes, we also may ask you to send written proof.
- If I do not qualify now, may I apply later? Yes. You may apply at any time during the school year. For example, children with a parent or guardian who becomes unemployed may become eligible for free and reduced-price meals if the household income drops below the income limit.
- 10. What if I disagree with the school's decision about my application? You should talk to school officials. You also may ask for a hearing by calling or writing to the following contact person: Dr. Mark Gleichauf, Superintendent P.O. Box 70 Hebron, Ohio 43025 or call 740-928-5878
- 11. May I apply if someone else in my household is not a U.S. citizen? Yes. You or your child(ren) do not have to be a U.S. citizen to qualify for free or reduced-price meals.
- 12. What if my income is not always the same? List the amount that you normally receive. For example, if you normally make \$1,000 each month, but you missed some work last month and only made \$900, submit the report with the routine amount of \$1,000 per month. If you normally get overtime, include it, but do not include it if you only work overtime sometimes. If you have lost a job or had your hours or wages reduced, use your current income.
- 13. What if some household members have no income to report? Household members may not receive some types of income that are asked for you to report on the application or may not receive income at all. When this happens, please write a 0 in the corresponding field. However, if any income fields are left empty or blank, those also will be counted as zeroes. Please be careful when leaving income fields blank.
- 14. We are in the military. Do we report our income differently? Your basic pay and cash bonuses must be reported as income. If you get any cash value allowances for off-base housing, food, or clothing, it also must be included as income. However, if your housing is part of the Military Housing Privatization Initiative, do not include your housing allowance as income. Any additional combat pay resulting from deployment also is excluded from income.
- 15. What if there is not enough space on the application for my family? List any additional household members on a separate piece of paper and attach it to your application. Contact your child's school or JENNIFER STOVER at JSTOVER@LAKEWOODLOCAL.K12.OH.US or call 740-928-4526 EXT.5017 to receive a second application.
- 16. Why am I being asked to give my consent for an instructional fee waiver? Ohio public schools are required to waive the school instructional fees for children that quality for free meal benefits. School food service personnel must have parent consent to share the student meal application if your child(ren) quality for a fee waiver. If you agree to allow your child(ren)'s meal application to be shared with school officials to see if they qualify for a fee waiver then select yes in part 5. If you do not wish for that information to be shared, then select no in part 5. Answering no to this question will mean your child will not be considered for a fee waiver. Answering this question either way will not change your child(ren)'s free or reduced-price meal eligibility.
- 17. My family needs more help. Are there other programs we might apply for? To find out how to apply for Ohio Supplemental Nutrition Assistance Program (SNAP) or other assistance benefits, contact your local assistance office or call 877-852-0010.

## A household member is any child or adult living with you.

# IF YOUR HOUSEHOLD RECEIVES BENEFITS FROM THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM (SNAP) OR OHIO WORKS FIRST (OWF), FOLLOW THESE INSTRUCTIONS:

Part 1: List all household members and the school name and grade level for each child.

Part 2: List the 7-digit case number for any household member (including adults) receiving SNAP or OWF benefits.

Part 3: Skip this part.

Part 4: Skip this part.

Part 5: Answer yes or no and sign your name if you would like the application to be checked by school officials to determine if the child(ren) qualifies for a school instructional fee waiver.

Part 6: Sign the form. The last four digits of a Social Security Number are not necessary.

Part 7: We are required to ask for information about your children's race and ethnicity. This information is important and helps to make sure we are fully serving our community. Responding to this section is optional and does not affect your children's eligibility for free or reduced-price meals.

Part 6: Sign the form. The last four digits of a Social Security Number are not necessary.

Part 7: We are required to ask for information about your children's race and ethnicity. This information is important and helps to make sure we are fully serving our community. Responding to this section is optional and does not affect your children's eligibility for free or reduced-price meals.

#### If some children in the household are foster children:

Part 1: List all household members and the school name and school grade level for each child. For any person, including children, with no income, you must check the "No Income" box. Check the box if the child is a foster child.
