This affidavit must be signed in the presence of a notary. The District has a notary on staff who can be used to notarize the various portions of this affidavit.*

- **Part One of this affidavit is to be completed by the Mahwah resident(s) with whom the student(s) will be or is residing.**
- **Part Two of this affidavit is to be completed by the non-resident parent(s) or legal guardian(s) of the student(s).**
- **Part Three of this affidavit is to be completed by the landlord of the Mahwah resident(s) with whom the student(s) will be residing, in the event that the resident leases property in Mahwah without a formal written lease.**

PART ONE (1) - Sworn Statement of Mahwah Resident(s)
