
- Grades K-8 Survey

 - Questions pertaining to an older student's experiences.

Survey: Opportunity to Opt-Out



Feedback from our students is critical to our equity audit and all voices should be heard. Particularly, the student experience and the voices attached to those experiences will be critical to hear.

After thorough review of the student survey that will be sent to all families, each parent will have the opportunity to opt out their children from participation in the survey.

- To opt out, the parent will need to e-mail their respective school principal, listing the child's name, and the request to opt out of the survey.
 - Due by December 8, 2022.
 - Opt-out students will have alternative assignment during survey administration time.

On-site conversation: Opportunity to Opt-Out

Parents may elect to refuse to have their children meet with or speak to a representative of US².

To opt out, the parent will need to e-mail their respective school principal, listing the child's name, and the request to opt out of the on-site conversation.

- Due by January 6, 2023.
- Opt-out students will not be approached by US² staff for a direct conversation.
