Once a child in foster care is identified, the Colorado River Union High School District #2 Foster Care Point of Contact (POC) shall be notified. The CRUHS#2 Foster Care POC will execute the procedure for ensuring children in foster care that need transportation to their school of origin will promptly receive transportation in a cost-effective manner and in accordance with section 475(4)(A) of the Social Security Act (42 U.S.C. 675(4)(A)), and will also determine how that transportation will be provided, arranged, and funded.
