17. Recommended Adoption of Emergency Resolution – Award of Contract without Bidding and Advertising (Attachment)

Between the months of December 2022 and March 2023, more than eleven atmospheric river events swept through California resulting in a state of emergency being declared by the Governor on March 1, 2023, and a subsequent March 9 Presidential Emergency Declaration to support communities impacted by the severe winter storms.

The rain and windstorms caused significant damage to the roof of Building D (modular) on the SBCEO Cathedral Oaks campus. The roof in Building D has been leaking during this storm season and getting progressively worse with each storm. An inspection of the ceiling and the roof on March 17, 2023, revealed visible mold on the interior plywood lining resulting from leaks in the roof. The sources of the leaks were identified throughout the roof and due to decomposition of material it was determined that the entire roof needs to be replaced as soon as possible. The roof has been patched numerous times in the past but there is now significant damage that can no longer be addressed with temporary solutions.

Building D houses the California Children's Services (CCS) Medical Therapy Unit (MTU) and currently the gym area of the building is closed. The office and one other room in the building have been deemed safe for use by staff and students for the time being. However, services to students have been significantly impacted without access to the gym and the unique equipment that resides in the space. A replacement of the roof is necessary for our students to be able to receive all of the therapy services that they require to be active and healthy.

Pursuant to Government Code section 53850, and the competitive bid requirements contained in Public Contract Code section 20111, in order for this repair work to be conducted in an expedited manner, the board is required to pass a resolution unanimously and with the approval of the County Superintendent of Schools. SBCEO's immediate need to replace the roof resulting from the storms is a qualifying event for this exemption.

The superintendent recommends adoption of Resolution No. 2317, which recognizes an emergency exists and authorizes SBCEO to enter into a contract without bidding and advertising to repair Building D, the CCS Medical Therapy Unit (MTU) facility, immediately.

Administrative Services Division

Director of Facilities: The new director of facilities, Mary-Beth Gallas, began work at SBCEO on March 20. She will be introduced at the April 6 County Board of Education meeting.

Associate Superintendent of Administrative Services Steve Torres and Mary-Beth will provide a brief update, at the April board meeting, related to the emergency repair work at the Hope Center (resolution passed at last month's board meeting).

They will also preview an action item for next month's board meeting related to lease renewals for classroom and office space for SBCEO.

Curriculum and Instruction Division

Community Schools Planning Grants: The Community Schools Support Team (from C&I and Ed Services) have been providing support for the three districts (Cuyama, Guadalupe, and Lompoc) who secured 2-year planning grants for community schools

last year. At the end of last calendar year, they worked closely with 7 additional local educational agencies (LEAs) to apply for the final round of planning grants. All seven were awarded these grants at the last State Board of Education (SBE) meeting and will begin their two-year planning process. The [California Community Schools Partnership Program](#) (CCSPP) defines a community school as any school serving pre-Kindergarten through high school students using a “whole-child” approach, with “an integrated focus on academics, health and social services, youth and community development, and community engagement.” As a school improvement strategy, community school initiatives enable the LEA and school to work closely with educators, students, and families to understand and address the unique needs, assets, and aspirations of the school community. Community schools then design their own curricula and programs to support the whole child and partner with community-based organizations (CBO) and local government agencies to align community resources to realize a shared vision for success. They improve student outcomes by addressing students’ academic, cognitive, physical, mental, and social-emotional needs. The LEAs are Buellton Union, College, Orcutt, Santa Barbara Unified, Santa Maria-Bonita, Santa Maria Joint Union HSD, and SBCEO. Each will receive about \$200,000 for planning.

Teacher Programs: The teacher of the year selection committee has moved to phase two of the process, now conducting interviews and classroom observations. The County Teacher of the Year will be announced at the May County Board of Education meeting. We are also in the nomination process for the Crystal Apple Awards. Ten (10) school employees (2 elementary teachers, 2 secondary teachers, 2 certificated support providers, 2 administrators, and 2 classified staff) will be awarded a crystal apple and an honorarium (provided by one of our sponsoring partners) at the Education Celebration on May 11 at the Buellton Marriott, where all of the grant winners will also be celebrated as we unite our business partners and the teachers whose projects they funded.

UPK: The Universal Pre-Kindergarten Community of Practice kicked off with enthusiastic engagement and collaboration from Early Childhood, Pre-K and TK leaders from Santa Barbara, Goleta, Solvang, Los Olivos, Lompoc, Orcutt, Cuyama, multiple charters, the California Preschool Instructional Network (CPIN) network, and private preschool providers, as well as our own Early Care and Education staff. In addition to community building and networking, participants received state policy updates, resources, and opportunities. They engaged in meaningful knowledge building through facilitated dialogue about topics such as the complexity and importance of Pre-K play.

English Learner Supports: As part of our Universal Support component of differentiated assistance, we have been curating data across various student groups. At the last Curriculum Council, we focused on English Learners/Multilingual Learners and the various data sets that LEAs can use to analyze outcomes and improve performance. Santa Barbara County is consistently 4th or 5th among the 58 counties in percentage of English Learners enrolled in our schools. Yet, we have the lowest percentage of Long-Term English Learners (LTELs). Lowest is best. It means that we are most successful in ensuring that students are making progress to reach proficiency within the expected timespan. Through our networks, we have been collaborating on

reclassification criteria and building awareness about the new Observation Protocol for Teachers of English Learners (OPTEL) tool, which will be required next year. Most of our support for English Language Development involves long-term job-embedded professional development, customized to the districts we are supporting.

Math, Science, Computer Science Professional Learning Grant: SBCEO is partnering with San Joaquin and Monterey county offices of education to apply for the 50-million-dollar Mathematics, Science and Computer Science Professional Learning Grant intended to serve the entire state. The fifty million dollars over four years will be used to establish statewide and local communities of practice across the entire state, aligning with all other improvement initiatives, while building, expanding, and deepening our relationships with existing professional learning and content partners. We will lead the charge in providing every COE the opportunity to actively lift up the needs of their community and build their capacity to serve them, while being able to design specifically for our county needs. The grant will be awarded in June.

Literacy: The Reading Brain in the Digital World: As we have been engaging our district and charter leaders in learning about the science of reading, literacy research and resources, and the impacts of digital expansion and AI, our latest deep dive has been into the emerging research question about how digital devices affect the reading brain. As a result, we are beginning a virtual book study of Maryanne Wolf's *Reader Come Home: The Reading Brain in a Digital World* after the spring breaks. Wolf describes the relationship between the process of reading and the neuroscience of the brain and provides a third point beyond our current hunches and opinions, combining research, timeless questions, and narrative for us as educators to consider: what is nurtured and what is diminished by various print media. She makes the case for developing a "biliterate" (print and digital) reading brain. Acclaimed author and researcher from UCLA also featured in the recently released ["Narrowing Down to Find Common Ground: Shared Agreements for Effective Literacy Instruction in California."](#) Maryanne Wolf will be one of our speakers next year in the Literacy Series for Professional Learning.

Student Events:

- **Mock Trial:** The County Mock Trial finals took place the first weekend of March. Our County Champion, Dos Pueblos High School, placed second in the state tournament, with junior Jacob Molina taking home honors as Best Defense Attorney of the tournament.
- **Spelling Bee:** The County Spelling Bee was held on March 9, where 54 students competed in the elementary and junior high divisions. We awarded trophies for first, second and third place. First and second place winners in each division will go on to compete in the state spelling bee in Stockton in May. Volunteers from the Masons, Women's Service Club of Goleta, and Women's Town and Country served as judges and proctors along with our student events team.
- **Science Olympiad:** The Regional Science Olympiad was held at UCSB on March 11. Students competed in 23 different events, with Santa Barbara County students taking home 44 individual medals.

- **Math Superbowl, North County:** North County Math Superbowl was held on March 29 at the Santa Maria Fairpark.
- **Battle of the Books:** There will be 3 Battle of the Books Competitions this year: on April 19th, we will host the elementary individual competition virtually. The in-person team competition for elementary students is on April 27th at the SBCEO Auditorium, and the junior high virtual individual contest takes place on May 3rd.
- **Poetry Slam:** The Santa Barbara County High School Poetry Slam and Spoken Word Exhibition will take place on Thursday, May 4 after the board meeting in the SBCEO Auditorium from 4:30 – 6:00 p.m.

Educational Services Division

Career Technical Education (CTE)

Industry Teacher Tours: The next round of Industry Teacher Tour Days, a collaboration with the Santa Maria Valley Chamber, is coming up in North County. CTE teachers tour three businesses to learn more about what will prepare their students to be job ready in that specific sector. A lunch with networking time is also provided by the business and/or Chamber. The next Teacher Tour will be April 4th, focused on the Transportation sector. Arts, Media, & Entertainment will be highlighted on April 24th, including a tour of the new Allan Hancock Fine Arts Complex. Teachers in the hospitality sector will tour industries on May 2nd.

Teacher Externships: The CTE program is planning to offer teacher externship opportunities to CTE teachers. The externships are tentatively planned for this summer. Teacher externships are a unique professional development opportunity where teachers become immersed in a company to learn about the current skills and competencies needed to succeed in that industry or career path. The externship, which will be offered during school breaks, typically lasts for 1-2 weeks. Teachers will be paid a stipend through CTE grant funding.

Externships present an opportunity for educators to learn new methods, analyze labor market information, and incorporate skills that meet current industry standards, while providing collaborative time with business leaders to enhance and develop the content taught in CTE classes. The opportunity strengthens an educator's teaching abilities and allows them to experience and then bring up-to-date, relevant, real-world context to the classroom. It improves teachers' pedagogical practice by increasing the connection between theory and action.

Children's Creative Project (CCP)

CCP Programming Update: CCP programs continue to expand. To date, there is a commitment of over \$490,000 in contracts through the Artist in Residency program for the 2022-23 school year. The Touring Artist program is also experiencing an increase this year. To date, over \$109,617 has been committed for the Touring Artist program across 122 bookings. CCP staff are currently exploring several community partnerships in service to youth, including a possible partnership to bring arts collaborations to other

Educational Services programs such as a mural and art program at Peter B. FitzGerald Community School.

I Madonnari Festival: CCP has officially launched production of the 2023 I Madonnari Festival to take place on May 27-29. CCP is hoping to improve the overall festival experience for the community. CCP is looking forward to featuring both student artists as well as performers. They are also hoping to spotlight another youth organization doing good work in the community. Last year, CCP spotlighted MEChA from San Marcos High School. This year's spotlight is yet to be determined.

All proceeds from the festival go directly back into the organization to support arts programs within Santa Barbara County. CCP is securing square and major sponsorships. Children and Family Resource Services (CFRS)

Welcome Every Baby (WEB) Update: As reported in previous county board meetings, the Welcome Every Baby program will sunset at SBCEO when all funding has been exhausted at the close of this fiscal year, June 30, 2023. The nurses received layoff notices as planned in March. One healthcare organization, Planned Parenthood California Central Coast, has expressed interest in continuing the WEB services in the community and is exploring this with a due diligence period to determine their ability to fund it through billing and fundraising efforts.

Educational Services Coordinator

Student Behavioral Health Incentive Program (SBHIP): The Student Behavioral Health Incentive Program (SBHIP) is having its Kickoff Meeting April 6th. SBHIP, overseen by the Department of Health Care Services (DHCS), provides funding to participating districts (SBCEO-JCCS, Carpinteria, Cuyama, Guadalupe, Lompoc, Santa Maria-Bonita) to increase behavioral health access to Medi-Cal qualifying students.

SBHIP aims to increase access to school-based behavioral health services for Medi-Cal eligible students. It aims to accomplish this by:

- breaking down the silos that currently exist in child and adolescent behavioral health services;
- increasing the number of TK-12 students enrolled in Medi-Cal who receive behavioral health services;
- increasing the availability of non-specialty services on or near school campuses;
- addressing the health equity gap and disparities in access to behavioral health services.

The kickoff meeting is for local community-based organizations interested in partnering with districts in our county to provide these much-needed services to students. Our

Promotores Network is one of the identified partners in the county that will be supporting students and their families.

Juvenile Court and Community Schools (JCCS)

Student Behavioral Health Incentive Program (SBHIP) at Peter B. FitzGerald

Community School: JCCS was awarded \$419,000 by the Student Behavioral Health Incentive Program (SBHIP) based on a needs assessment conducted in September 2019. These funds will support the creation and implementation of a Family Navigator Team which includes the hiring of a Youth Outreach Mentor, a Licensed Clinical Social Worker, a Substance Use Disorder (SUD) Counselor, and Health Linkages Navigator (Promotores). This team expands current behavioral health programs and services at all three campuses to meet the needs of students.

Career Technical Education Manufacturing Class: Students at Los Robles School have been learning about manufacturing this year as part of their Career Technical Education (CTE) class. A favorite project has been designing and building a skateboard that the students get to take home upon exiting the program. Ska8makers is a CTE manufacturing project where the students construct a skateboard using 7 layers of Canadian maple veneers. The veneers are glued together a couple of sheets at a time and pressed into a foam mold using a vacuum bag. When the gluing is complete, the board is sanded and prepared for artwork. Students then use CorelDraw to create their design. Once the design is approved, they move to the laser printer to etch their design onto the board. The final step is the assembly, where they add on the deck tape, trucks, and wheels. Human Resources Division

New Applicant Tracking System: Human Resources went live on March 16 with the NeoEd applicant tracking system for classified recruitment. Highlights of the new web-based system include a modern application interface, greater ease of candidate communication, enhanced automation of processes, and integration with social media for advertising. HR believes the new system will significantly improve the applicant experience and will enhance our classified recruiting efforts.

Special Education Division

Staffing Update: SBCEO currently employs adults with disabilities in both our Santa Maria and Santa Barbara Special Education offices through Path Point and the Vocational Training Center (VTC). The Special Education director met with management from VTC in Santa Maria to explore ways to provide additional work for their clients at SBCEO.

Outreach/Recruitment: On March 21, 2023, two Support Team members attended the Lompoc High School and Cabrillo High School career fairs. They shared information about SBCEO, as a local employer, and discussed opportunities for employment after

graduation via paraprofessional positions which can open a pathway in the field of education.

Professional Development: Special Education and Early Care and Education (ECE) leadership attended a professional development series offered by WestEd called *Beginning Together - Inclusion Facilitator Institute*. The goal is to strengthen preschool inclusive practices between departments. The training provided tools, resources, and a framework to increase collaboration among staff and inclusive options for children of all ages.

18. Recommended Adoption of Emergency Resolution – Award of Contract without Bidding and Advertising

Late December 2022 and through January 2023, Santa Barbara County communities experienced historic rainfall levels causing significant flooding and infrastructure damage. President Biden declared a Federal Natural Disaster for multiple counties in California on January 14 and added Santa Barbara County to the list on January 18, 2023. Governor Newsom also declared a Disaster State of Emergency for all of California on January 4, 2023, which was followed by an Executive Order of January 16, 2023 to support communities impacted by the storm event.

SBCEO's Hope Center was affected by the storms and repair work needed to be done immediately. Staff that worked in the Hope Center had to vacate the facility due to the damage. Repair work needed to be done so that staff could return to offices. In its current state, the condition of the building presented serious safety concerns, and SBCEO had no alternate facilities to place employees.

Pursuant to Government Code section 53850, and the competitive bid requirements contained in Public Contract Code section 20111, in order for the repair work to be conducted in an expedited manner, the board would be required to pass a resolution unanimously and with the approval of the County Superintendent of Schools. SBCEO's immediate need to remediate mold resulting from the storms was a qualifying event for the exemption.

The board adopted Resolution No. 2316, which recognized an emergency existed and authorized SBCEO to enter into a contract without bidding and advertising to repair the Hope Center facility immediately.

The County Board of Education (County Board) believes that the County Superintendent of Schools (County Superintendent) renders essential services that promote the success of students and of the educational programs of the County Education Office and should be fairly compensated for such service. In accordance with law, the County Board shall fix the salary of the County Superintendent and may adopt a remuneration package that includes, but is not limited to, salary, allowances, health and welfare benefits, and other benefits as appropriate.

The County Board may determine the County Superintendent’s salary at any point during the term of employment. However, any decreases in salary shall only be considered in consultation with legal counsel.

The County Superintendent shall not increase the County Superintendent’s own salary, financial remuneration, benefits, or pension without bringing the matter to the attention of the County Board for its discussion and approval. (Education Code 1209)

Any discussion and/or action taken on the County Superintendent’s remuneration, including, but not limited to, salary, financial remuneration, benefits, or pension, shall take place in open session at a regularly scheduled meeting of the County Board, which shall not be held during a special meeting. (Education Code 1209; Government Code 54956)

During the open meeting at which the County Board will take final action on the County Superintendent’s salary or fringe benefits, the County Board shall, prior to taking action, orally report a summary of the recommended action. [GC 54953]

Any action taken on the County Superintendent’s remuneration shall be reflected in the County Board’s minutes. [GC 53262]

The County Superintendent shall receive reimbursement for actual and necessary traveling expenses. (Education Code 1200, 1201)

Legal Authority and Purview of the County Board

The County Board relies on a number of regulatory and legal proclamations to substantiate its authority to fix the salary of the County Superintendent, namely:

1. Article 9 (IX), Section 3.1 (b) of the California Constitution – “Notwithstanding any provision of this Constitution to the contrary, the county board of education or joint

county board of education, as the case may be, shall fix the salary of the county superintendent of schools.”

2. Education Code (EC) 1207 – “... the salary of an incumbent (county superintendent) shall not be reduced during the term for which he (sic) was elected or appointed or for any consecutive new term to which he (sic) is elected or appointed.”

However, the California Attorney General has opined in 61 Ops.Cal.Atty.Gen. 384 (1978) that the adoption of Section 3.1(b) of Article 9 of the California Constitution voided the provision of EC 1207 and that the County Board retains power to fix the salary of the County Superintendent including increasing or decreasing the salary during the County Superintendent’s term of office.

The Attorney General also opined that any decrease could not be retroactive. Given the conflict recognized by the Attorney General between the California Constitution and EC 1207, it is recommended that the County Board contact legal counsel prior to decreasing a County Superintendent’s salary.

3. EC 1209 – “A county superintendent of schools shall not increase his or her salary, financial remuneration, benefits, or pension in any manner or for any reason without bringing the matter to the attention of the county board of education for its discussion at a regularly scheduled public meeting and without the approval of the county board of education.” [Refer also to Government Code (GC) 54956]

Considerations for Setting the County Superintendent’s Salary

Comparison Agencies

It is the intention of the County Board to consider relevant comparable information when determining the County Superintendent’s compensation.

Information may include, but is not limited to:

- Class III counties - County superintendents in the Class III counties
- Largest school districts in Santa Barbara County (Lompoc Unified, Santa Barbara Unified, Santa Maria-Bonita, Santa Maria Joint Union)
- Region 8 COEs (County offices are clustered into regions. In the California County Superintendents organization, Region 8 includes the following counties: Kern, San Luis Obispo, Santa Barbara, and Ventura)

Health and Welfare Benefits, Travel, Retirement Contributions, Life Insurance, and Other Additional Stipends

The County Superintendent shall receive the same

- Health and welfare benefits
- Travel reimbursement

- Retirement benefits
- Life insurance benefits
- Graduate degree stipend
- SBCEO-issued cell phone

consistent with certificated management.

The County Superintendent's membership dues to the Association of California School Administrators (ACSA) shall be paid for by SBCEO.

Longevity

The County Superintendent shall receive the same longevity, consistent with certificated management.

Annual Increases

When certificated management receives negotiated salary increases, the County Board may consider the County Superintendent for the same increase.

Resolution No. 2317

Emergency Resolution

Award of Contract without Bidding and Advertising

WHEREAS, pursuant to California Public Contract Code §20113, the Board may, by unanimous resolution, by vote of members present, determine that an emergency exists wherein certain repairs, alterations, work, or improvements are necessary to permit the continuation of existing programs and services, or to avoid danger to life or property; and

WHEREAS, a resolution regarding such circumstances permits the Santa Barbara County Education Office (SBCEO) to make a contract for the performance of labor and furnishing of materials or supplies for the purpose of addressing the existing situation without advertising for or inviting bids; and

WHEREAS, the emergency is described in detail below:

Between the months of December 2022 and March 2023, more than eleven atmospheric river events swept through California resulting in a state of emergency being declared by the Governor on March 1, 2023, and a subsequent March 9 Presidential Emergency Declaration to support communities impacted by the severe winter storms. The rain and windstorms caused significant damage to the roof of Building D (modular) on the SBCEO Cathedral Oaks campus. The roof in Building D has been leaking during this storm season and getting progressively worse with each storm. An inspection of the ceiling and the roof on March 17, 2023, revealed visible mold on the interior plywood lining resulting from leaks in the roof. The sources of the leaks were identified throughout the roof and due to decomposition of material it was determined that the entire roof needs to be replaced as soon as possible. The roof has been patched numerous times in the past but there is now significant damage that can no longer be addressed with temporary solutions.

Building D houses the California Children's Services (CCS) Medical Therapy Unit (MTU) and currently the gym area of the building is closed. The office and one other room in the building have been deemed safe for use by staff and students for the time being. However, services to students have been significantly impacted without access to the gym and the unique equipment that resides in the space. A replacement of the roof is necessary for our students to be able to receive all of the therapy services that they require to be active and healthy.

WHEREAS, in order to promptly continue essential programming and services, and to avoid further health risks or continued property loss, it is essential to replace the roof of Building D immediately; and

WHEREAS, the estimated cost to resolve this emergency is expected to exceed \$15,000; and

WHEREAS, this resolution does not set aside any bonding or security otherwise required by law;

NOW THEREFORE, BE IT RESOLVED, that the Santa Barbara County Board of Education declares an emergency and with approval of the County Superintendent of Schools authorizes the SBCEO Administrator of Internal Services to enter into a contract or contracts for the roof replacement or other work required to resolve the building impact without advertising or inviting bids that may include additional work required by local and state agencies.

Resolution No. 2318

Support of Funding for County Office of Education Operated Juvenile Court and Community Schools

WHEREAS, juvenile court and community schools are operated by county offices of education to provide public education for students;

WHEREAS, students enrolled in court and community schools need individualized academic, social-emotional learning, and career technical education courses of study; and

WHEREAS, juvenile court schools provide public education for students who are incarcerated in facilities operated by county probation departments; and

WHEREAS, community schools provide opportunities for students to prepare for post-secondary education, meet graduation requirements, college and career transition support, access quality prenatal and parenting education, and receive health and mental services; and

WHEREAS, students attending a juvenile court or community school have unique needs, including higher rates of trauma requiring mental health support; obstacles to receiving specialized supports in a comprehensive school setting; a need for specialized supports and services; credit deficiency and unfinished learning; and more; and

WHEREAS, the teachers, paraeducators, and staff at juvenile court and community schools are highly specialized, able to serve multiple grade levels, multiple subjects, use restorative practices and inclusionary practices; and

WHEREAS, students attending juvenile court and community schools are underserved by the current attendance-based funding model, known as “average daily attendance” (“ADA”); and

WHEREAS, juvenile court and community schools have unpredictable enrollment levels throughout a school year, while their specialized staffing costs remain consistent; and

WHEREAS, the ADA-only funding model does not support core and ongoing staffing needs and does not account for the variable enrollment and attendance of the court and community school model; and

WHEREAS, the ADA-only funding model does not account for the complexity of the realignment of the Department of Juvenile Justice affecting many counties; and

WHEREAS, an ADA-only funding model creates inequitable programs across the 58 counties; and

WHEREAS, Assembly Bill (AB) 906 (Gipson) was introduced on February 14, 2023, to improve the funding model for juvenile court and community schools.

NOW, THEREFORE BE IT RESOLVED, that the County Superintendent of Schools and the Santa Barbara County Board of Education urge the State Legislature and Governor's Administration to support sustainable fiscal resources for the provision of public education and college and career transition for youth enrolled in juvenile court and community schools by establishing a funding formula that supports the provision of academic, college and career readiness, and social-emotional services.

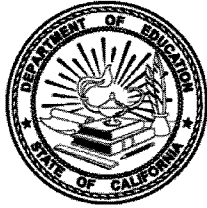
