Enrollment Priority

Students must be residents of the state of California to be eligible to apply to a California charter school.

Students are considered for enrollment with the following priority status as set forth in the school’s charter:

1. Students presently enrolled in SunRidge Charter (guaranteed enrollment for the following year).
2. Students who are the children of SunRidge employees working at least 0.5 FTE.
3. Students who have siblings enrolled in SunRidge’s classroom-based program (siblings include children living in the same household who share at least one parent, stepparent or guardian).
4. Students enrolled in the SunRidge HomeSchool Program for a minimum of 5 months as of March 1.
5. Children who are residents of Twin Hills Unified School District or children of an employee of the Twin Hills Unified School District.
6. All other applicants.

Offers of admission will be made by letter to the applicant’s family, to be sent within ten (10) days of the enrollment lottery. The family will have five (5) business days from the date of mailing to respond. If the family does not respond, one additional phone call will be made, and the family has two (2) business days to contact the school. If the family still does not respond, the applicant will be considered to have “declined” and will lose his/her place in the class.
