A. Call to Order Upon Reaching A Quorum

Meeting called to order at 6:30 p.m. Barb Wilson read the ACSD Vision aloud and asked everyone to share their earliest school memory during introductions.

After public comment, Barb Wilson also pointed out the Summary of Roberts Rules of Order document included in the meeting materials. She proposed adopting the Small Board version (for Boards of 12 or so members) instead of the Full Board version, as the official parliamentary procedures for full boards are more formal.

James Malcolm stated that he does not feel that Board meetings are disordered. It's important for all members to understand how the different Roberts Rules formats work, but does not want to see the group become fractured by an overly rigid procedure.

Barb explained that per state statute, the Board needs to declare how it will operate, and is supposed to follow Roberts Rules.

Joanna Doria said that her understanding was that the Board has been operating as a small Board, so it would be good to clarify that officially.

Barb asked for a motion. Joanna made the motion to adopt Roberts Rules for small Boards.

Brian Bauer seconded. The voting began but Suzanne Buck and Mary Heather Noble called for Point of Order, noting that opportunity for discussion had not been provided. Barb opened the table for discussion.

Jamie McCallum asked what would change if we adopted the Roberts Rules for small boards procedure. Barb explained that it is less structured, motions would not required seconding, etc. Jason Chance asked about the difference between the procedures with respect to the Board Chair voting -- in Roberts Rules for regular boards, the Board Chair does not vote unless it would change the outcome of the vote. In small Boards, the Board Chair may vote at any time.

Lindsey Hescock, Steve Orzech, and Mary Heather Noble all expressed wanting more time to consider the change before voting. Brian noted that one of the differences is that Suzanne Buck noted that the Board has been using a sort of hybrid between the two -- the formality of seconding motions, but not following requirements of standing to address the Board. If the Board is to formally decide between one or the other, they should have time to make an educated decision.

Steve Orzech made a motion to table the issue. Mary Heather seconded. All voted in favor of tabling the issue.

Barb asked for a motion to relax the requirement to stand for addressing the Board. Steve Orzech seconded. All voted in favor.

2. Public Comment

Karen Morris, XC and Track coach at MUMS gave a statement requesting that the Board and Administration consider adding an Athletic Director position to the middle school. She and her husband have been coaching at MUMS for 14 years, and have recently experienced some challenges with the administrative turnover at MUMS. The Vice Principal has traditionally been the person who provides administrative support for the after-school sports (scheduling, busing, etc.), and with every recent change in that position comes challenges to bring the new person up to speed on team needs, parent communication, etc. She acknowledged that there are many other higher priority challenges at the school, but believes that the after-school sport programming would thrive if there was a position devoted to supporting it. She suggested Shelley Harrison, currently an administrative assistant at MUMS -- she had previously done much of the work before being moved from the MUMS front office.

Hugh McLaughlin of Middlebury spoke up in support of Karen Morris's comment, and noted that others have also suggested Shelley Harrison as the best person to organize and support MUMS after school sports programming.

B. Recommendation to Approve Minutes of March 13, 2023

Tricia Allen noted typo-s in Section J, Other: The months should be "May."

Ellen Whelan-Wuest noted the corrected last name for "Avery Causton" in the Public Comments is "Thompson."

Jason Chance asked about the vote totals for the Vice Chair vote, and if those can be added. Barb Wilson explained that Jason had asked her about the vote totals, since the Charter requires Vice Chair to be determined by the majority of the Board vote, and there were 3 candidates.

Barb reached out the Linda Barrett, who had counted the votes for Vice Chair on March 13th -Linda confirmed that the vote tallies were as follows: Lindsey Hescock - 7, Suzanne Buck - 6, and Mary Heather Noble - 0. Jason asked if the minutes could be corrected to reflect that information.

Mary Heather Noble stated that she could not correct the minutes of March 13th to include that information because it was not presented during that meeting, but that the minutes for today's meeting (March 27th) would reflect this information.

Motion to approve the minutes of March 13, 2023, as

C. Approve ACSD Bills

James Malcolm reported that he and Jason Chance had reviewed the bills, and presented the following:

Payroll: \$929,597.08

Payroll: \$759.40 Payroll: \$506.34

McGilton Fund: \$648.00 (for Rikert Nordic Skiing)

General Fund: \$1,030, 356.70 (which includes ~ \$450K in Health & Dental, as we'll as Transportation costs and reimbursements for universal Pre-K).

James Malcolm also noted the tight turnaround between when warrants are presented and when the Treasurer cuts the checks, so the Finance Committee has limited time to review the bills. He commended the administrative team on their preparation & assistance in the review process. Suzanne Buck offered to help read bills if needed.

Motion to approve and pay the ACSD bills as presented.

D. Report of the Superintendent 15 min

Peter Burrows provided some quick updates about education legislation that is moving forward in the State Senate/House of Reps crossover. The VT Superintendent's Association and VT Principal's Association are always watching this, to keep an eye on legislation that will impact school budget and operations. These are the ones that are still active:

- Continuation of Universal School Meals. This will likely pass and is currently being drawn from the Education Fund. This would significantly impact ACSD budget.
- Funding of Private Schools with Public Money. All public education-affiliated organizations are advocating for the removal of public funding toward private schools. Ruth Hardy is very involved in this effort.
- Pre-K. There was contemplation of providing Pre-K for all 4 year old's, but it has turned into

another study of the issue. The current program only provides funding to cover 10 hours per week, and is universally distributed, which means some families are getting what they need (and other families with means are getting a benefit they don't need).

- School Construction Aid. The state has paused the PCB study because they do not have a plan for funding remediation if/when contaminants are found. They have already earmarked a significant portion of funds for Burlington School District and there's not enough left for the rest of the state. There is a Legislative Task Force to look into the funding.

E. Report of the Board

1. Professional Appointments

Peter Burrows reported the professional appointments for the 2023-24 academic year, referencing the list in the meeting materials.

Ellie Romp, Jason Chance, Barb Wilson, Mary Heather Noble, and Lindsey Hescock all asked clarifying questions about certain appointments. Steve Orzech asked when teacher contracts are due back. Peter reported that they will go out around April 15th, and are due back around May 15th, though some will wait until June 1st to sign and return.

Motion to accept the list of 2023-24 Professional Appointments as presented. Move: Suzanne Buck Second: James Malcolm Status: Passed

2. Action: Approve Recommended Principal Candidates

Peter Burrows presented the recommended candidates to appoint to the Ripton Elementary School and MUHS principal positions.

Ripton Elementary School Principal: The hiring committee recommends Megan Cheresnick, who is currently serving as an interventionist at Bridport School. Nicole Carter reported that she had all the right experience and qualities: experience as a classroom teacher, literacy interventionist, and administrator. Megan made a brief statement. Joanna Doria commented on a thoughtful thorough process. Lindsey Hescock asked if this was a FTE position -- it is 0.6 FTE principal and 0.4 FTE interventionist.

Joanna Doria made a motion to approve appointment of Megan Cheresnick for the Ripton Principal position. Jamie McCallum seconded. All voted in favor.

MUHS Principal: The hiring committee recommends Caitlin Steele, who has been serving as the interim principal from her post as the Assistant Superintendent of Teaching and Learning. Peter Burrows spoke about Caitlin's experience, passion, commitment and intelligence -she will do great things at MUHS. Caitlin made a brief statement, noting her commitment to her current work as Assistant Superintendent as well as her excitement for the Principal position. She is excited about working directly with teachers and students again.

Jason Chance made a motion to approve appointment of Caitlin Steele to the MUHS Principal position. Suzanne Buck seconded. All voted in favor. Several Board members spoke in favor of the process and the result.

Mary Heather Noble asked about the timeline/process for filling Caitlin's position. Peter Burrows answered that the position has been posted

immediately and that he will form a small group to help him. Lindsey Hescock asked who decides on that position -- will it be an Assistant Superintendent or a Director. It will be a Director of Teaching and Learning, and Peter makes the recommendation.

3. Discussion: Committee Assignments 5 min

Barb Wilson reminded Board members to reach out to her with any questions or concerns about committee assignments. She has also asked Heather Crowley to post draft minutes for Board and Committee meeting minutes on the website within 5 days of the meetings.

Steve Orzech told the Board that the Negotiations Committee has met already and is looking to open the teacher contract to provide higher salaries to stay competitive with the market for this season -- ACSD is behind both MAUSD and ANWSD for teacher pay. More to come later.

4. Discussion: Board Training 10 min

Barb Wilson reported that she has been working with Peter Burrows to schedule a Board Training in April or early May. They have contacted VSBA, but the person who did the training is no longer with them. They have another person who is available (Elaine, who the Board considered using to assist with the Superintendent Search process). Barb said that they will work to propose some dates, and that we will have another retreat/training in August with the new Superintendent.

Peter Burrows distributed copies of "The Governance Core: School Boards, Superintendents, and Schools Working Together." Barb said that the training would cover content from the Introduction, Chapter 1, "Moral Imperative and the Governance Core" and Chapter 6, "Governance Culture." Mary Heather Noble also suggested adding Board Norms. Suzanne Buck suggested scheduling the training for a Saturday, so that Board members can be fully focused. Mary Heather agreed. Ellen Whelan-Wuest asked about the expected duration, and Ellie Romp requested that dates be established asap. Jamie McCallum and Lindsey Hescock requested to avoid scheduling on a weekend.

5. Action: Bank Account Resolution and Invoice Payment Authorization 5 min

Matt Corrente presented the memo requesting authorization for bank and invoice payment authorization -- this is an annual requirement to authorize the Finance department to do its work on the Board's behalf.

Motion to approve the Bank Account Resolution and Invoice Payment Authorization as corrected to reflect current school names.

6. Action: McGilton Fund Disbursement 5 min

Jen Kravitz provided a brief summary of the McGilton Fund for new Board members, and presented the current request for distribution of \$7,500 for enrichment activities for Mary Hogan School students.

James Malcolm asked about the equity issue of continuing to allocate endowment funds to select elementary schools in our unified state. There was some discussion on how the district might reconcile inequities in funding for enrichment activities. Jen Kravitz suggested that the Board/Admin identify the enrichment that it would like all students to experience, and determine how to fund equitably with operational budget, parent group funding, and/endowment funding as needed.

Motion to approve the McGilton Fund Disbursement request as presented.

7. Discussion: Superintendent Search Update

30 min

Mary Heather Noble provided an update on the Superintendent Search process, and outlined to-do items for the Board:

The application window closes March 28th at midnight. We only have 5 applications so far, but many people apply last-minute. McPherson & Jacobson will send initial candidate videos by April 6, so we can elect those we want to interview on April 11th.

- 1. The Board needs to decide whether to view initial candidate videos as a group or individually.
- 2. The Board needs to determine how to identify key stakeholders to participate in the finalist in interview process.
- 3. The Board needs to finalize its list of interview questions -- to be done during executive session.

Highlights from the discussion:

Several Board members spoke in favor of watching candidate videos as a group, and watching them individually. Given the number of applicants, the Board may have time to review candidate videos at the special Board meeting on April 11th. Mary Heather will circle back on this after checking in with the consultant on March 29th.

The Board will use the same general stakeholder categories as were used for the initial stakeholder forums to identify preferred qualifications: Parents, Students, Teachers & Staff, Administrators, and Community. The plan is to make sure that participants from each group are able to commit to both finalist interviews and will ask the same questions of finalists. The goal is to allow the stakeholder groups to identify their own participants and ask their own questions -- they will be given 45-mins to an hour.

Mary Heather, Barb, and/or Emily Blistein will reach out to the school principals to solicit a few parents from each school community, being sure to request that special education parents are included. They will also reach out to the teacher and staff union reps to request a few teachers and staff to meet and ask questions of the finalists. And they will ask the high school principal to find a diverse group of students who can also commit to meeting all the finalists. Administrators will likely self-select to participate in the process, and perhaps have lunch with finalists. The Board would also like to have a community zoom in the evening, where candidates can provide a very brief introduction and take questions from participants.

ACSD Superintendent's Board Report

Date: April 10, 2023

Strategic Plan Goals

Educational Success, Equity & Student Services - Nicole Carter & Caitlin Steele

Even with Caitlin at MUHS, we are moving forward with a lot of good work to support ACSD's systems for access, success, and belonging, pk-12. The PYP teaching and learning coordinators-Joy and Brandi- are supporting PYP IB training taking place this week, while the MYP and DP coordinators- Cindy, Pam, and Eileen- are supporting MUHS and MUMS as they refine their universal screening processes and proficiency reporting. The entire team is getting ready to prepare for Tier 1 professional development during the 23-24 school year by meeting with Laura Nugent and Tracey Harrington, ACSD Special Education Directors, to align Tier 1 professional development with staff practices at Tiers 2 and 3. In addition, Laura and Tracey are strengthening ACSD's evaluation process, preparing for changes on July 1, 2023, as well as supporting Special Educators with specialized professional development aligned with recent and coming changes to Vermont's Special Education regulations. In other words, we are all busy doing really good hard work to improve our Multi Tiered System of Services, build sustainable compliance practices, and ensure that teachers who are practicing in any Tier, have the professional development they need to ensure access, success, and belonging for all ACSD students.

Finance and Operations - Matthew Corrente

- Facilities we have resumed discussion at committee level regarding the Facilities Bond Initiative and will be preparing an update to the full Board as necessary to seek approval for the Approach Phase.
- Negotiations following a comparative analysis of our Support Personnel salaries, we have
 worked with the Union and Negotiations committee to propose two side letter actions for
 FY24 to increase wages and aid in recruitment and retention. In the first, all personnel
 would receive a \$1/hour raise. In the second, the first two steps of our 27 step pay scale
 would be eliminated, thereby moving all Step 1 and 2 employees to step 3.
- Finance As the third quarter wraps up, we are preparing the next Budget status report and will bring those projections forward to the Board in May. Meanwhile, we are refining our fiscal year end systems, writing next year's grants, and prepping for the coming budget season.

Communications and Engagement - Emily Blistein

- Supporting the superintendent and principal searches
 - We have a lot of hiring happening at ACSD! In March, I offered assistance to the MUHS
 principal search committee and the Board in their Superintendent search to support
 community engagement in those processes.
- Action Team and the Next Strategic Plan
 - The Action Team began meeting in late January and updates are posted <u>here</u>.
 - The Action Team's primary focus is drafting the action steps and strategies that will go
 into the next strategic plan. This month they have been inviting folks from within ACSD
 and our community partners to share their perceptions and suggestions for action
 steps and strategies to ensure an equitable learning environment for all ACSD
 students.
- Family and Community engagement
 - I have spent time with our Teaching and Learning team in an effort to discuss how we can best educate the parent community about IB. At this point, I am working on a newsletter that lays out a basic overview of IB. In my time here, one of the biggest challenges I see is that the parent community still feels that they don't understand IB and many valid questions, concerns, and misunderstandings have emerged over the past few years that we haven't addressed directly. My goal is to work with our Teaching and Learning team to create a parent-focused overview of the IB program in our schools that answers basic questions, offers more learning for those who are interested, includes two videos that our Teaching and Learning team have created, and includes an FAQ section based on the leading questions, concerns, and misunderstandings that responds to this question in our March newsletter and pulls from questions our Teaching and Learning team hears.

- Social media
 - A few highlights (hyperlinks will take you to the posts) Our secondary teachers had a wonderful day of Diversity, Inclusion, and Equity professional development one workshop was led by our MUHS students! Our Ripton students created a clay "puzzle" piece of a map of Vermont that is on display at the VT Statehouse! Our MUMS students had an awesome skateboarding clinic during flex blocks! Our MUHS students met Rep Becca Balint at a Career and College pathways event.

Bridport Central School - Matthew Brankman

BCS has cockroaches, we have ukuleles and soon we will have chickens!

Not to worry, the <u>Madagascar Hissing Cockroaches</u> are part of an exploration in kindergarten. Ms. Way's class is learning about their habitat, diet, and lifespans in their "science tank." Students are learning about inquiry and the scientific method. If you stop by and see them, please don't call them gross! As one student said, "all living things are beautiful...sort of."

In Ms. Cunningham's music class, our 4th and 5th graders are building ukuleles! This project, which incorporates art as well, allows students to learn about instruments from the ground up. 





Cornwall School - Heather Raabe

In March, thanks to two grants, we were able to bring author and illustrator Michael Rex to Cornwall School as well as to Shoreham Elementary School and Bridport Central School. Librarian, Abby Adams, received grant funding through ACEEF, and we also received some grant funding from the Gilligan Fund.

Mike is a friend of mine from growing up - we've known each other since Kindergarten, and he even shared our kindergarten class picture! Mike presented at all three schools over two days. He shared the process he follows in creating a book, from idea - or two ideas - to writing to drawing, and he demonstrated how he draws using a student as a model. While at Cornwall, he also gave feedback after listening to some student story ideas, and he did a short drawing lesson. Since then, there have been lots of kids talking about ideas and how to draw and write stories to share their ideas!







Also during March, the Cornwall Action Committee (CAC), which was a student initiative started last year as a follow up to an IB unit, grew! The CAC now consists of some students from each class. They met with a representative from HOPE and, as a result of that meeting, the CAC is in the process of planning a food drive. Students are creating posters and have developed this <u>site</u>, which will be posted in our newsletter, to share information about the drive. As we think ahead toward the end of the year, we are planning concerts, all school outdoor activities, events with visiting experts as well as planning for the 5th grade exhibition, transitioning to MUMS and holding information sessions for incoming kindergarten students.

Mary Hogan School - Jennifer Kravitz

March started with our 5th graders skiing at the Snowbowl for the first time and it ended with beautiful playground weather. The swing in the weather in March kept us on our toes but also led to some serious fun. Students were out building forts and slides on the snow banks at recess. The 3rd graders were able to find some tracks in the woods at Mary Hogan and then in Battell Woods as part of their tracks and scat learning. 2nd graders studied water - in all of its various forms during the month by just going outside! Buddies went sledding together. Kindergarten met the mobile weather lab from WPTZ as part of their inquiry into the weather. MESA hosted a family skate event at the rink that was packed! It was a good month for snow, weather, and fun.



During March, we began a community weaving project. This project started with an idea in Miss Kim's preschool class and has grown to include the whole school. The idea of the project is that communities are woven together by all of the individual personalities that are part of them. And





individually, we look like one but together we make a beautiful new piece of art. Students are each adding a piece of fabric to the art and it will be displayed in April in the B wing hallway.







March ended with a fabulous community celebration of math and learning at our Math Night on 3/30. This event was fully designed by the student council and included cookie decorating (with math on the cookies, of course), a scavenger hunt, Jeopardy math games, an adult math test, and more. We also had a spaghetti dinner that brought about 250 people together for a meal and conversation. The night was full of joy and curiosity with significant student leadership of the event. As we plan future events, having student voice in the design will be a priority for Mary Hogan.

March is also a transition month within the school - a time when we begin to think forward to next year while also living in this year. We have started our process for determining the class sections for each grade. These will be shared on Friday with families. We don't anticipate changes in returning teachers' assignments. And, we have begun the hiring process. Natalie Krizo will be transitioning roles this coming year from classroom teacher to interventionist. There are two classroom teachers we are hiring for as well as the Wellness and Learning Center Coordinator and some open paraprofessional positions.

We are also thinking forward to the transitions for students. We have started to plan for the rising 5th graders' culminating events at Mary Hogan and their transition to MUMS. Classroom teachers have met with counselors at MUMS about all of their students, as well. As the 5th graders begin to leave, we are also planning for the incoming kindergarten class, which seems to be one of the bigger incoming classes in a few years. The kindergarten and preschool teachers met last month to think about how to make the transition as smooth as possible for students, families, and teachers. That process will unfold over the next few months.

Ripton Elementary School - Tracey Harrington

March was a celebration of the arts at Ripton Elementary School. The students had a wonderful time putting on a short version of Alice in Wonderland which was rehearsed and performed in two full casts. From being cast for different parts, to learning their lines, to creating costumes and building the sets, the students worked hard all month long and pulled off two amazing shows. It was great to see students being brave, trying something new, working together towards a common goal and experiencing the thrill such an accomplishment can bring. We are grateful to the parents and staff who helped make this possible, especially Tara Gallner, our director extraordinaire. The other celebration of art was coordinated through our art teacher, Eileen Gombosi as part of Youth Art Month at the Vermont Statehouse. Several student artists had their artwork on display at the Statehouse in Montpelier all month long. The Pit-Fired pottery creations of Eli, Esme, BB, Hazel, Sophia, Chase, Tenlyn, Cecily, and Axl were selected to be exhibited along with the charcoal drawings of Phoebe, Cecily, Nathaniel, Gabe and Eleanor. In April we are excited to welcome Artist in Residence Fua Nascimento to Ripton Elementary for five days of Capoeira. This Brazilian "martial art disguised as a dance" was created by African slaves in Brazil as a resistance movement in the 16th century and is a complex blend of dance and acrobatic martial arts. Fua came to RES in 2018 and it was an unforgettable experience of culture,

community and movement. We are grateful to ACEEF and FORS for the opportunity to have him working with our students and staff once again. The spring promises to be a busy but exciting time like always. We're really looking forward to it!

Salisbury Community School - Bjarki Sears

March came in a like a lamb, and went out like a polar bear, but it was a good month at Salisbury Community School. One success we would like to highlight is the American Heart Association "Kids Heart Challenge", led by Physical Education teacher Sierra Thornton, a set of



Robert's Rules of Order Differences for Small Boards (Version 1 - 4/3/2023)

The text below provides a summary of the Robert's Rules of Order applicable to school board meetings. *If there is a different procedure for those boards who have adopted Robert's Rules for Small Boards, it is highlighted in italic below the corresponding rule.* It should be noted that a comprehensive list of the rules is not provided in this document, only those most frequently used. Refer to the VSBA Robert's Rules of Order training webinar and support materials for a more in-depth tutorial. Links are provided below:

<u>Instructions for Board Meetings</u>

- Please come prepared to the meeting. It is important to review all meeting materials prior to the meeting to enable the meeting to run efficiently and smoothly.
- Agenda items will be either discussion items or action items to be voted upon by the board. New items, which are not on the agenda, can be discussed under Other Business, however action (i.e., a vote) will not be taken on those items until a future meeting where it can be publicly warned in advance of the meeting.
- Robert's Rules of Order are the basic rules of order for this meeting except where Vermont Law takes precedence¹. The board cannot change Vermont State Law; however, the board can change Robert's Rules with a 2/3 vote. For boards less than 12 or so members, the board can decide to use Robert's Rules of Order for small boards with a 2/3 vote. RONR² p. 464 49:21.
- An action must be moved and seconded by the board, then restated by the board chair before it is under consideration and debate on the Action may begin. RONR p. 28 4.2.
 After the board chair restates the motion, the person who made the motion has the right to speak first in the debate. RONR p. 38 4.27, 360 42.9.
 - Small Board Version Difference: An action only needs to be moved and does not require a second. (2)
 - Small Board Version Difference: If the chair is a member, they may, without leaving the chair, speak in informal discussions and debate, and vote on all questions. Informal discussion may be initiated by the chair which, in effect, enables the chair to submit their own proposals without formally making a

motion as described in 4:4-8 (although the chair has the right to make a motion if they wish). (7)

- Actions may have only one amendment at a time associated with them, and amendments to an action, likewise, may have only one amendment at a time associated with them. RONR p. 124 12.11. The amendment must be germane to the motion currently on the floor.
- After a board member has spoken once on a particular action, they will not be recognized a second time during discussion on that action or amendment until all other Board Members who wish to speak on the issue for the first time are given an opportunity to do so. Robert's Rules only allows a given speaker to speak twice on a given motion and limits the duration of speeches to 10 minutes. RONR p. 38 4.28, RONR p. 39 4.29, p. 367 43.8, p. 368 43.12.
 - Small Board Version Difference: There is no limit to the number of times a member can speak to a debatable question. Appeals, however, are debatable under the regular rules – that is, each member (except the chair) can speak only once in debate on them, while the chair may speak twice. (3)
- Votes on actions will be conducted as voice votes. However, a paper vote can be requested by one Board Member before a vote is taken or immediately after a voice vote occurs.
 - Small Board Version Difference: When a proposal is perfectly clear to all present, a vote can be taken without a motion's having been introduced. Unless agreed to by unanimous consent, however, all proposed actions must be approved by vote under the same rules as in larger meetings, except that a vote can be taken initially by a show of hands, which is often a better method in small meetings. (5)
- The board chair cannot vote on a voice/hand vote, unless their vote changes the outcome of the vote (i.e., to break a tie vote or cause a tie vote). The chair can vote if a paper vote has been requested. RONR p. 384 44:12.
 - Small Board Version Difference: The chair, speak in informal discussions and debate, and vote on all questions. (7)
- Other Small Board Version Differences:
 - Members may raise a hand instead of standing when seeking to obtain the floor and may remain seated while making motions or speaking. (1)
 - o Informal discussion of a subject is permitted while no motion is pending. (4)
 - The chair need not rise while putting questions to a vote. (6)

Robert's Rules of Order Differences for Small Boards (Version 1 - 4/3/2023)

- Other business not already on the agenda can be discussed by the board as part of Other business on the agenda, however motions cannot be introduced and voted upon. This allows the public the opportunity to weigh in prior to a vote taking place.
- All motions, remarks and discussion must be addressed by the board chair (RONR p. 372 43.22). The board chair will do their best to recognize you in the order that you have raised your hands. You must be recognized to speak, even to "Move the Previous Question" (Stop discussion and ask for a vote on the Motion (Question)). RONR p. 189 16.5.3.
- Comments must be confined to the merits of the question (motion). A board member will not be allowed to engage in personal attacks on a member of the board or their motives. RONR p. 371 43.20, 43.21. If a member of the board, engages in such behavior, the chair or any member of the board can call a member to order. The chair would say: "The member is out of order." Another board member would say: "Madam Chair, I call the member to order." At which point, if the chair agrees, calls the member out of order.
- The role of the board chair is to help accomplish the business of the Board. Board members should raise their hand and ask questions if they don't understand what is happening or if they want to do something but don't know how to proceed.
- Board members should tell the chair if they feel the chair is ruling improperly. Board members have the right to challenge the board chair's rulings. RONR p. 242 24.1, 385 44.13.
