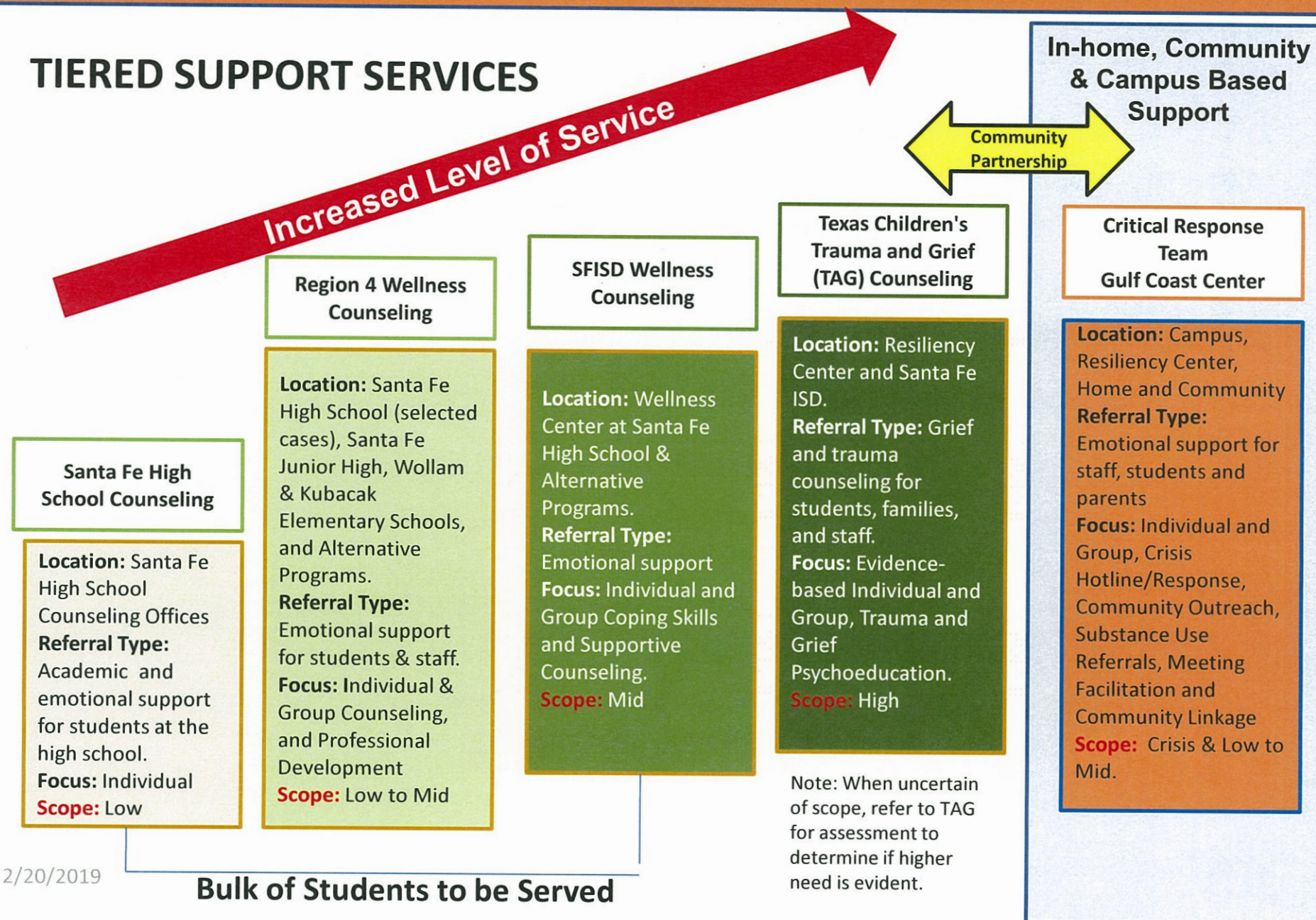

Coverage: On location 7-Days a week.
Focus: Community activities & supportive counseling, walk-in and by appointment counseling sessions.
Scope: Low to Mid

Gulf Coast Center's Critical Response Team

Location: Community, Home, and Resiliency Center
Coverage: As scheduled and crisis response.
Focus: Intensive short-term intervention counseling, disaster and incident response, linkage to community resources, community partner education, and facilitation of collaboration.
Focus: Provided to adults, families and community members.
Scope: Crisis & Low to Mid

Texas Children's Trauma and Grief Center

Location: Resiliency Center
Coverage: Tuesday through Friday
Focus: Evidence-based treatment for traumatized and grieving individuals and families, trauma and grief psychoeducation..
Scope: High
