Hearing of the Public Non-Agenda Items

Karen Gouge addressed the Board regarding the tragedy at Robb Elementary in Texas and school safety in general. Ms. Gouge expressed concerns the KEA has regarding School Resource Officers ratios and the availability of South Community staff to address counseling needs. Ms. Gouge' asked the Board to improve on the availability and number of staff to provide SRO and counseling services to students.

Mr. Henderson responded on behalf of the Board. He thanked Ms. Gouge for her comments and the Board shares in the grief at the tragedy that took place at Robb Elementary School. Mr. Henderson commented the Board is adamantly supportive of all measures to make our schools safe and secure for students, staff and visitors. With that in mind, the Board has directed our administrative team to review our current safety measures and to work with our District Safety Committee to determine where we can make improvements to the safety and security of our schools. We know the crucial role our School Resource Officers and our School Counselors play in building relationships with our students and staff and keeping our schools safe, so I want to assure you that the recommendations you have brought to us tonight will also be considered during these discussions with our District Safety Committee. Thank you again for bringing your concerns and recommendations to the Board tonight.
