SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found [HERE](#).

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. To enable New York State's LEAs to begin to obligate ARP-ESSER funds by USDE's May 24, 2021 deadline, the application for LEA 90% base ARP-ESSER allocations is being administered by NYSED as a two-part application process:

- ARP-ESSER Application – Part 1: The first step was for each LEA to submit signed assurances to NYSED by May 24, 2021. Upon receipt of signed LEA assurances, NYSED provided an email notice to the LEA of substantially approvable application status. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.
- ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Title VIII of Division B of the CARES Act directs the Department to carry out the Education Stabilization Fund, of which the ARP ESSER funds are a part. Section 2001 of the ARP Act provides for the Department to make grants to each SEA from the ARP ESSER funds. The District engaged in meaningful consultation with students; families; school and district administrators (including special education administrators); and teachers, principals, school leaders, other educators, school staff, and their unions. The entire school community was surveyed using Parent Square, a digital tool with surveys sent to all staff members and all parent/caregivers within the district. After survey results were compiled, the BoE and administrative team used the survey data in addition to district attendance, academic performance and climate survey data to prioritize needs and develop the ARP plan.

The District's Reopening Committee, which is comprised of members of the public healthcare system, stakeholders, parents and school district personnel, will continue to meet regularly, at least every six months, to assess and adjust the Reopening and Safety Plan to return to in-person instruction. The Committee will also review ARP funding plans and spending biannually throughout the pandemic, ensuring that funds are used to meet the safety, academic and social emotional needs of students, particularly those disproportionately impacted by the COVID-19 pandemic. Changes to the ARP spending plan, will be developed in response to changing conditions as needed and posted on our website with continuous opportunities for stakeholder feedback provided through Parent Square digital surveys and monthly Board of Education public comment sessions before being revised and adopted by the BoE.

Per CDC Guidelines Ventilation in Buildings | CDC, Beekmantown Central Schools will improve indoor building air ventilation and quality to decrease SARS-CoV-2 viral particles spread between people. ESSER 3 funding will enhance indoor air ventilation safety practices to support safe and continuous school operations for students and staff members engaged in in-person instruction. The District will hire two maintenance support staff to conduct quarterly air quality testing throughout the District and to conduct air quality ventilation maintenance and additional disinfecting in all District buildings. Funding will also be used to purchase air quality filters for District heating and cooling units. The filters will be replaced at least quarterly in all classrooms, offices and common spaces.

The District will use the Fastbridge digital tool to evaluate data for students' social and emotional status and assessment data within the core Math and ELA curriculums to assess academic need. This will inform our Multiple Tiered Level of supports for students. Data and Instructional Teams will review assessments and use the newly refined model of RtI and the AIS framework to determine the type and frequency of prescribed interventions. The District has interventionists in each building to provide these additional supports.

Students will be provided additional tiered instruction outside regular instruction hours. We will identify students who are well below grade level in single or multiple subjects using multiple assessment points including norm referenced national screeners, teacher created assessments, and teacher recommendations. Interventionists will conduct direct outreach to students who have demonstrated poor attendance in person or remotely. Credit recovery will be made available to students who have failed one or more courses that affect graduation or grade promotion. A variety of options, including in-person and remote tutoring -both during and after school hours- online classes and a Summer Bridge Program will be provided.

The District will utilize the 20% reserve to actively engage students in high interest summertime activities with caring adults to enhance their perception of and engagement in schools. We will utilize a Summer Bridge program to bridge the learning loss gap from the end of school to the beginning of the next year using researched based interventions and remediation as needed to help students remain on track to graduate. Stipends for the services of two District nurses, one at Cumberland Head Elementary and one at the Main campus will also be needed to conduct the Bridge Program in order to ensure the safety of student participants.

AU #4 ARP Funding will expand Career and Technical Educational instruction in technologies aligned to local industry needs for new entry level employees, thereby increasing the college and career readiness of low-income and disenfranchised students who have been struggling to complete high school during the pandemic.

AU#8 ARP funds will also support college and career readiness for disadvantaged students by increasing access to CAP and AP coursework at no charge.

AU #12- ARP funding will support Dstance Learning Facilitators who will provide assistance and outreach to students participating in remote learning.

AU#16- Funds will be used to employ an Academic and Behavioral Interventionist who will provide outreach to students at Beekmantown Elementary and Cumberland Head Elementary Schools to address behaviors that have arisen since the COVID pandemic, including poor attendance, disengagement and failure to meet academic growth standards.

AU #20- Funds will provide grants procurement, management and accounting staff members who will apply for, manage and coordinate the integration of federal grant program dollars to support the continuity of district education services during the ongoing COVID pandemic.

The LEA will ensure that the use of ARP ESSER funds will respond to the needs of all students, particularly those disproportionately impacted by the COVID-19 pandemic, including students from low-income families, students of color, children with disabilities, students experiencing homelessness and children in foster care. The District's Multi-tiered System of Support Plan will identify and provide interventions for disadvantaged students needing academic and/or social emotional support. An ARP-funded Elementary Interventionist will work within each building's Instructional Support Team to address student behaviors by prescribing interventions for poor attendance, disengagement and/or academic failure. The interventionist will monitor progress and conduct out-reach to parent/guardians as needed, particularly for students living in foster care and/or homeless settings. Furthermore, outreach and supports for remote instruction will be provided by 1.5 FTE Distance Learning Facilitators who will assist students during periods of quarantine and for those participating in longterm remote instruction.

The District's required 20% set-aside will fund the stipends of 40 teaching and educational support staff and 4 special education aides who will conduct a Summer Bridge Program to help close the achievement gap amongst students who have been disproportionately impacted by the pandemic, including the high percentage of rurally isolated, low-income students, students identified for special education services and the very small population of minority students who reside within the district.

As the pandemic continues, revised plans will reflect changes to safety recommendations from the CDC, state and local health departments to support safe in-person instruction.
