**Background**

On March 27, 2020, Congress passed, and the President signed into law the Coronavirus Aid, Relief, and Economic Security (CARES) Act. The CARES Act provides \$30.75 billion nationwide in an Education Stabilization Fund to prevent, prepare for and respond to the coronavirus, of which:

- \$13.2 billion is for the Elementary and Secondary School Emergency Relief Fund (ESSER) to support the ability of local educational agencies (LEAs), including charter schools that are LEAs, with emergency relief funds to address the impact that Novel Coronavirus Disease 2019 (COVID-19) has had, and continues to have, on elementary and secondary schools across the nation; and
- \$2.95 billion is for the Governor's Emergency Education Relief Fund (GEER) which provides grants to Governors for the purpose of providing educational agencies with emergency assistance to address the impact of COVID-19.

Governor's Emergency Education Relief Fund (GEER)

New York State has been allocated \$164.2 million under the Governor's Emergency Education Relief Fund (GEER). The entirety of New York State's GEER funds were programmed in the 2020-21 enacted New York State budget through the application of a "pandemic adjustment" to partially offset the state share of state aid to school districts. Pursuant to the direction of the Governor's Office and the Division of the Budget, GEER funding is being allocated to the State's 673 major school districts. GEER funds are not being allocated to LEAs that are charter schools, Special Act School Districts, or school districts employing fewer than eight teachers. These funds will be allocated to eligible school districts using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent fiscal year (2019-20).

Elementary and Secondary School Emergency Relief Fund (ESSER)

New York State has been allocated \$1.037 billion under the Elementary and Secondary School Emergency Relief Fund (ESSER). ESSER funds to school districts were programmed in the 2020-21 enacted New York State budget through the application of a "pandemic adjustment" to partially offset the state share of state aid to school districts. ESSER funding is being allocated all LEAs, including charter schools and Special Act School Districts, that received 2019-20 Title I, Part A subgrants. Pursuant to the terms of the CARES Act, Local Educational Agency (LEA) allocations were calculated using the relative shares of grants awarded under Title I, Part A of the Elementary and Secondary Education Act (ESEA) for the most recent fiscal year (2019-20).

- 1. In the space provided below, please describe how the LEA will determine its most important educational needs as a result of COVID-19 (150 words or less).**

Beekmantown CSD, located just north and west of the City of Plattsburgh, is comprised of two elementary, one middle and one high school and has a Districtwide free and reduced lunch rate of 44.4%. Parent and student surveys in addition to several virtual meetings have been held to identify educational needs and address reopening concerns in light of the COVID-19 pandemic. The District was proactive, and therefore successful, implementing K-12 virtual learning using Goggle Classroom applications and School Tool throughout the spring of 2020. In planning for reopening schools, the District presented three options to families through a survey. The first is full-time in-school attendance. The second is enrollment in the new Beekmantown Virtual School of Learning and Development and the third is homeschooling. With over 80% of families having responded, just under 30% of students are engaged in full-time virtual school participation and 1% will be homeschooled. The remaining 69% of students attend in-person.

- 2. Does the LEA intend to use GEER funds to promote or support remote learning?**

- 3. In the space below, please describe how the LEA intends to assess and address student learning gaps resulting from the disruption in educational services (150 words or less).**

The district is working hard to develop student schedules and groupings for in-school as well as synchronous and asynchronous virtual instruction that includes whole group, small group and independent work time. Initially, homogeneous grouping will be used with groupings loosely based on assessment data collected prior to the closing of schools in March, but also taking into consideration student attendance in the virtual spring semesters, class participation/engagement and the assessments of school work and projects completed throughout the spring. Students and teachers- whether in-school or interacting 100% virtually- will continue using the Google Classrooms platform to ensure seamless instruction and learning, should classrooms or entire buildings need to be closed again.

Beekmantown CSD, located just north and west of the City of Plattsburgh, is comprised of two elementary, one middle and one high school and has a Districtwide free and reduced lunch rate of 44.4%. Parent and student surveys in addition to several virtual meetings have been held to identify educational needs and address reopening concerns in light of the COVID-19 pandemic. The District was proactive and therefore successful in implementing K-12 virtual learning using Google Classroom applications and School Tool throughout the spring of 2020. In planning for , reopening schools, the District presented three options to families through a survey. The first is full-time in-school attendance. The second is enrollment in the new Beekmantown Virtual School of Learning and Development, and the third is homeschooling. With nearly 90% of families having responded, just under 30% of students will be engaged in full-time virtual school participation and 1% will be homeschooled. The use of ESSER funding directly responds to safety measures needed to reopen and technology gaps for effective virtual learning.

Groupings will be loosely based on assessment data collected prior to the closing of schools in March, but also taking into consideration student attendance in the virtual spring semesters, class participation/engagement and the assessments of school work and projects completed throughout the spring. Students and teachers- whether in-school or interacting 100% virtually- will continue using the Google Classrooms platform to ensure seamless instruction and learning, should classrooms or entire buildings need to be closed again.
