

## 2023-2024 RADNOR HIGH SCHOOL STUDENT PARKING PRIVILEGE AGREEMENT

**All rules of the Pennsylvania Vehicle Code will be enforced on the Radnor High School campus.  
Violations will be reported to police.**

### **RESPONSIBILITIES REQUIRED FOR A STUDENT TO MAINTAIN AN RHS PARKING PERMIT:**

Parking for students is at a premium at Radnor High School. Permits are available to Seniors through a random lottery, as there are a limited number of spots. Student parking regulations for the 2023-2024 school year are as follows:

1. If selected, permits may be purchased for \$75.00 (\$37.50 per student for sharing and semester option) in the Main Office after completing the necessary paperwork. Spaces are limited. The parking permit must be hanging from the rear view mirror at all times while the vehicle is on campus.
2. Parking is permitted only in the numbered spaces. There will be no parking permitted outside of these lots (ex - in fire lanes, visitor, staff, administrative, any parallel parking spaces, etc.) at any time.
3. Students who violate parking regulations will be subject to disciplinary consequences.
4. Only the Radnor High School registered driver may operate his/her vehicle while on campus during school hours.
5. The speed limit on campus is fifteen (15) mph and all traffic signs must be obeyed.
6. Students may not loiter in the parking lots or in parked cars.
7. Any student driving in a reckless manner will have privileges temporarily or permanently revoked at the discretion of the High School Administration.
8. Any senior who received a final grade of an F in any class the previous year will not be eligible for a parking permit.
9. Only students with Open Campus Privileges may obtain/possess a parking permit.
10. Students must sign out through our Raptor System by using their student ID. Our Raptor System is located at the security desk by the main office. Failure to follow Open Campus procedures may result in a loss of parking privileges.
11. Parking privileges will be suspended for chronic disciplinary offenses.
12. The RHS smoking policy directs action to be taken for possession of tobacco products on campus. This policy includes tobacco products/vaping devices and oils in cars driven or parked on campus.
13. Important: Parking permits are transferable among family vehicles ONLY. **Permits MAY NOT, under any circumstances, be sold, borrowed, or traded.** Mutually agreed upon transfers must be approved by an administrator. Should any parking permit be sold, borrowed, or traded, the student will lose their permit and not be able park on campus.
14. The Radnor High School Administration reserves the right to search any vehicle located on Radnor High School property reasonably suspected of containing illegal matter such as drugs, alcohol, weapons, explosives, or stolen property, or any other items related to a student's suspected use or possession of such illegal matter.
15. Any person parking on school district property must have a thorough understanding of the Radnor School District Parking Policy #223.
16. The High School will not be responsible for any vehicle or its contents while on school property.

Parking permits may be revoked or suspended for any violation of these regulations.

**No illegal matter such as drugs, alcohol, weapons, explosives, or stolen property may be transported, secreted or kept in any motor vehicle brought on school property.** The school district reserves the right to search any vehicle entering or parking on school property reasonably suspected of carrying or containing such matter.
