### Important Notes:

- All official actions and deliberations by a quorum of the members of the board shall take place at a meeting open to the public, unless otherwise allowable by law, and written minutes shall be kept of all open meetings.
- Boys' Latin shall give public notice of its first regular meeting of each fiscal year not less than three days in advance of the meeting and shall give public notice of the schedule of its remaining regular meetings for the fiscal year printed in a paid newspaper of general circulation and posted at the location(s) where the meetings are to take place.
- For all special or rescheduled public meetings Boys' Latin shall provide notice at least 24 hours in advance of the time of the convening of the meeting specified in the notice, with the notice being printed in a paid newspaper of general circulation and posted at the location(s) where the meetings are to take place.
- Boys' Latin shall post the agenda for all regular and special public meetings at least 24 hours in advance of the time of the convening of the meeting on the school's publicly accessible website, at the school's offices, and at the meeting location, with copies of the agenda available to the public at the meeting itself. Please note that the agenda shall include a listing of each matter of agency business that will be or may be the subject of deliberation or official action at the meeting.
