# VII. SUPERINTENDENT'S REPORT/INFORMATION REPORTS

#### A. Student Academic Data - Dr. Chris Robbins

Dr. Chris Robbins, Chief Learning Officer, presented a summary of the 2021-2022 ACAP and ACT scores. The test scores showed that 70% of Hoover students scored at or above grade level in ELA, 56% scored at or above grade level in math, and 60% scored at or above grade level in science. Compared to the 2020-2021 ACAP and ACT scores, these scores show a 4% increase in ELA, an 11% increase in math, and a 5% increase in science. These scores place Hoover City Schools among the highest-achieving school districts in the state in ELA, math, and science for 2022.

## B. Teacher/Parent Survey Results - Natasha Flowers

Mrs. Natasha Flowers, Coordinator of Federal Programs, presented the results from the recent Teacher and Parent Survey reports.

#### C. 2023-2024 School Calendar - Kelli Lane
