PLEASE READ BEFORE COMPLETING THE FOLLOWING SECTIONS: The following legal questions and background check information allow us as a school district to determine your eligibility for a volunteer service assignment which may include daily contact with students. It is important that you answer the following questions honestly. EPSDR3 reserves the right to require background checks and/or fingerprinting of any prospective or current volunteer, including parents, legal guardians, and stepparents. Background checks will reveal any and all instances in which you may have been arrested, summoned, charged or convicted for minor (such as underage drinking, shoplifting, simple assault, motor vehicle violations, etc.) and major offenses, both locally and nationally. If these types of things have occurred in your past, and you deny knowledge of such occurrences by answering "NO" to the applicable question(s), you will automatically be disqualified from volunteering with the EPSDR3 for at least one year. If you have had instance in the past which would require a good faith answer of "Yes" to any of the following questions, this will not bar you from volunteer considerations; each case is judged individually and many offenses, particularly minor ones, may not prevent you from becoming a volunteer for the EPSDR3.
