**Important health information for the upcoming 2023-24 school year**  
***(School Nurses will be available beginning August 28th 2023 for the 2023-24 school year)\****

**Student Health Requirements**

Physical exams with up-to-date state mandated immunizations are required at the following times:

1. Exam on or after August 28th 2022 prior to students entry into Kindergarten
2. Exam on or after June 30th 2022 prior to students entry into 7th grade
3. Exam on or after June 30th 2022 prior to students entry into 10th grade.
4. Exam within the calendar year prior to students entry into Pre-K (submitted annually)
5. Exam within the calendar year prior to students transferring into the district

The physical exam must be on the [State of Connecticut Health Assessment Record](#) for K-12 students or the [Early Childhood Assessment](#) for Pre-K Students/ELP (Early Learning Program) Students. For more specific information on physical exam requirements please click [here](#).

Students who participate in DHS interscholastic athletics must submit a valid physical exam per [CIAC guidelines](#) when registering under FamilyID for participation in high school interscholastic athletics. **Emergency Contact Information**

The school nurse uses the parent/guardian/emergency contact information collected in [ASPEN](#) to reach you in the event of a medical emergency. It is of utmost importance that the information provided is accurate and current. Parents/Guardians must complete the emergency information for each student electronically via the ASPEN system *upon enrollment, annually and ongoing if contact/medical information changes*.

**Medications**

A written medication order from an authorized prescriber with parent/guardian signature is required for school nurses, or in the absence of a nurse, other designated personnel to administer medication, including over-the-counter drugs. If a student is determined eligible for self administration of medication, this must be reflected on the medication order. **Medications must be in the original, properly labeled container and dispensed by a physician/pharmacist.** Over-the-counter medications must be delivered in an unopened, properly labeled container.
