

### **English 9:**

Grade Level:	9
Length:	1 Year
Period(s) Per Day:	1

### **ESSENTIAL UNDERSTANDING:**

The goal of the English Nine is to enable students to achieve greater skill in reading, writing, and thinking. The course will include reading and writing, and the study of language usage, grammar, and vocabulary. Materials used include a *Prentice Hall Literature* anthology, novels, and writing and Wordly Wise handbooks. Novels for this class include: *Lord of the Flies*, *The Absolutely True Diary of a Part-time Indian*, and *Bless the Beasts and the Children*.

### **Course Objectives and Expectations:**

- 1.) Read and comprehend a variety of literature and informational text.
- 2.) Produce clear and coherent writing in which the development, organization and style are appropriate to task, purpose and audience.
- 3.) Adapt speech to a variety of contexts and tasks, demonstrating command of formal English when indicated or appropriate.
- 4.) Practice English grammar and usage and build vocabulary sufficient for reading, writing, speaking and listening at the college and career-readiness level.
- 5.) Oral presentations

### **Student Objectives:**

#### **Upon completion of English Nine, students will:**

- 1.) Understand and respond to various forms of literature.
- 2.) Develop skills in written and oral language.

- 3.) Review and apply correct English language.
- 4.) Understand the organization of the library and the use of library resources.
- 5.) Understand literary terms (theme, satire, irony, plot, etc.) and be able to use literary terms to evaluate literature.
- 6.) Write papers supporting statements with concrete evidence based on both experiences and literature.
