- 8-20-3 The Board of Trustees of Marion P. Thomas Charter School approves the PPP Loan from Self Help in the amount of \$3,747,686.00.
- Marion P. Thomas Charter School, Inc. is subject to substantial economic uncertainty which makes the PPP loan necessary to support its ongoing operations in a fiscally prudent manner and in compliance with its Series 2018 Bonds financial covenants and the State of New Jersey Charter School Performance Framework Financial Performance Fiscal Ratios. Specific economic uncertainty and fiscal status includes:
- The School is a public school that does NOT charge tuition. It has received little/no funding increase (per pupil) that last few years and due to COVID-19 has been told to expect a 10% revenue cut from its primary revenue source, the State of New Jersey. The extent of the budget cut is not finalized as the State of New Jersey has postponed its budget process due to COVID-19. This is an extremely large revenue cut.
- The cost and scope of cleaning physical facilities for reopening post-COVID and maintaining clean facilities with social distancing is uncertain at this time and may be significant.
- The School is required pursuant to financial covenants in the Lease Agreements under Series 2018 Bonds to maintain a specific amount of cash on hand to ensure it is

economically able to operate. The requirement is estimated at over \$5,537,000 unrestricted cash on hand by June 30, 2021. The School's total general fund balance dropped from \$6,871,333 in 2016 to \$2,517,846 in 2018 which is substantially lower than the \$5,537,000 requirement in accordance with financial covenants in the Lease Agreements under the Series 2018 Bonds. The economic uncertainty related to COVID-19 revenue cuts and expenses is making it less likely to meet this financial covenant.

- A portion of the School's revenues are generated from two charter school subtenants, both of which are also subject to significant economic uncertainty including 10% cut in funding and increased operating costs.
- The School does NOT have a public bond rating and therefore has little to no access to capital markets. The School was turned away by an underwriter after issuance of Series 2018 Bonds for its most recent facilities projects. The School would not be able to obtain approval from existing lenders to incur additional indebtedness to support operating costs due to COVID.
- The School needs support to help ensure its successful positive total margin and cash flow from 2020 (internal, unaudited figures) can be continued post-COVID in order to comply with fiscal ratio targets and Series 2018 Bond financial covenants and continue to reverse its negative trend from 2016-2018 financial results.

In summary, the School has no source other than the PPP loan to support its financial operations and any other loan sources (even though not available) would be significantly detrimental to the business
