RE: Family Balance Policy

Dear Parent/Guardian:

To ensure every child will continue to be fed, Kewaskum School District will allow your Family Balance to go \$10.00 into the negative (-\$10.00). We would appreciate, however, if you would please try to keep your balance in the positive.

How Kewaskum School District will communicate with you:

- If you have selected in Family Access the email notification of low balance, a daily email will go out to you once your Family Balance falls under \$10.00 (in the positive). You will continue to receive those emails until your balance is over that amount.
- Phone calls will go out twice a week (on Mondays and Thursdays) once your Family Balance falls under \$10.00 (in the positive). You will continue to receive those weekly phone calls until your balance is over that amount.
- The Nutrition Services Secretary or School Principal will call any family that has a balance in the negative.

If a balance should fall below the -\$10.00, a token lunch will be provided to your child. A token lunch will consist of a cheese sandwich and a milk. If there is a continual problem with this negative balance, Kewaskum School District will reserve the right to deny your child any lunch.

At any point your balance falls into the negative (-\$0.01), your child will not be allowed to purchase any a la carte from our Nutrition Services Program. This would include an extra entrée, extra sides, or extra milk.
