

Regular Board Meeting
February 21, 2018

The Board of Trustees of the Oxnard School District met in regular session at 5:13 p.m. on Wednesday, February 21, 2018, at the Educational Service Center. CALL TO ORDER

A roll call of the Board was conducted. Present were President Debra M. Cordes and Trustees, Ernest “Mo” Morrison, Denis O’Leary, Veronica Robles-Solis and Monica Madrigal Lopez.
