Recommended Action	Authorization to Award the Request for Proposal for Nursing Services for the 2023-2024 school year.

### Public Content

**WHEREAS**, the Board of Education of the White Plains City School District on October 31, 2022, publicly advertised and invited sealed proposals for Nursing **Services** for the 2023-2024 school year. The proposals were required to be received by November 9, 2022;

**AND, WHEREAS**, proposals were evaluated on a weighted system established by the District for each of the categories to be reviewed. The evaluation criteria included special knowledge or expertise of the proposer, suitability for the District's needs, proposer credentials and certifications, quality of services to be provided, staffing/time available, and fee schedule as reasonably determined by the District;

**AND, WHEREAS**, on November 9, 2022, the White Plains City School District received nine (9) proposals for Nursing Services and the following providers PearlCare Search Group, LLC., White Glove Community Care, J & D Ultracare, Absolute Home Health Care Inc., NPORT Registered Nursing, Physical and Occupational Therapy and Speech-Language Pathology Services, PLLC., Sunbelt Staffing, SHC Services, Inc. DBA Supplemental Health Care, ATC Healthcare Services LLC., and Greenstaff Medical Staffing LLC. submitted proposals for the services and at the rates attached;

**THEREFORE, BE IT RESOLVED**, that based on the evaluation criteria established by the District, the Board of Education accepts the proposals and authorizes the Assistant Superintendent for Business to enter into an agreement with PearlCare Search Group, LLC., White Glove Community Care, J & D Ultracare, Absolute Home Health Care Inc., NPORT Registered Nursing, Physical and Occupational Therapy and Speech-Language Pathology Services, PLLC., Sunbelt Staffing, SHC Services, Inc. DBA Supplemental Health Care, ATC Healthcare Services LLC., and Greenstaff Medical Staffing LLC. to provide Nursing **Services** for a contract term of July 1, 2023 - June 30, 2024.
