Public Content

WHEREAS, The Board of Education of the White Plains City School District on November 18, 2022, publicly advertised and invited sealed proposals for Physical Therapy Services for the 2023-2024 school year. The proposals were required to be received by December 1, 2022;

AND WHEREAS, proposals were evaluated on a weighted system established by the District for each of the categories to be reviewed. The evaluation criteria included special knowledge or expertise of the proposer, suitability for the District's needs, proposer credentials and certifications, quality of services to be provided, staffing/time available and fee schedule as reasonably determined by the District.

AND WHEREAS, on December 1, 2022, the White Plains City School District received ten (10) proposals for Physical Therapy Services and the following providers KIDZ Educational Services, SLP, OT, PT, LMSW, Psychology, Audiology, PLLC., All About Kids, Rye Therapies of OT, PT, SLP, PLLC, HTA of New York Inc., Achieve Beyond, Creative Wonders OT, PT, SLP, PLLC, Westchester Therapy Solutions and Developmental Steps, LLC. submitted proposals for the services and at the rates attached;

THEREFORE, BE IT RESOLVED, that based on the evaluation criteria established by the District, the Board of Education accepts the proposals and authorizes the Assistant Superintendent for Business to enter into agreements with KIDZ Educational Services, SLP, OT, PT, LMSW, Psychology, Audiology, PLLC., All About Kids, Rye Therapies of OT, PT, SLP, PLLC, HTA of New York Inc., Achieve Beyond, Creative Wonders OT, PT, SLP, PLLC, Westchester Therapy Solutions and Developmental Steps, LLC. to provide Physical Therapy Services for a contract term of July 1, 2023 - June 30, 2024.
