Impact of Residential Development on Potential Enrollment:

Remember from the presentation & discussion by Zach Worthen (DecisionInsite / PowerSchool) on March 9, 2021, without increased residential development our student enrollment is projected to drop.

- Enrollment February 2020: 3892 students
- Conservative projected enrollment 2029-30:
 - 2824 students (w/o new homes)
 - 3455 students (w/ additional homes)
- Moderate projected enrollment 2029-30:
 - 3014 students (w/o new homes)
 - 3731 students (w/ additional homes)



Update of Residential Development & Potential Enrollment:

This summer DecisionInsite worked with Mount Joy Township, West Donegal Township, Elizabethtown Borough, and Conoy Township to updated the Residential Development Research for the 2021-22.

After we have our October 1 Student Enrollment data, DecisionInsite will run an updated set of Student Enrollment Projections.

 - If decision is yes,
 - Advertise for Public Hearing prior to end of October 2021 (15 day advertising requirement)
 - Hold Public Hearing between November 15 and 23 on possible school closures (90 day requirement until vote)
 - February 22, 2022 Board Voting Meeting
 - Vote on Alignment option that would include building(s) closures
