October 2021

 - Include community forum summary feedback from Sept.
 - Board/admin Discussion- if consensus is to consider possible school(s) closure then will place on the next meeting agenda



October 2021 (continued)

○ October 26 Board Meeting:

- Decision Board to consider School alignment with school closure(s).
 - **If decision is no**, then no further action regarding alignment
 - **If decision is yes**,
 - Advertise for Public Hearing prior to end of October 2021 (15 day advertising requirement)
 - Hold Public Hearing between November 15 and 23 on possible school closures (90 day requirement until vote)
 - February 22, 2022 Board Voting Meeting
 - Vote on Alignment option that would include building(s) closures
