The mission of Charter Home School Academy is to provide a positive alternative for parents who want to meet a child's needs by participating in their child's education at home. Charter Home School Academy is based on the belief that each student can succeed and deserves an education that is rigorous and well defined. We believe that success breeds success and that we can control the conditions of success by creating an environment where academic success is personalized and achievable for all children. Parents, working with credentialed teachers, prepare, monitor, and implement programs that enrich, challenge, and inspire students to embrace personalized academic success.

Primary goals of our program are:

To provide a viable option for students and parents needing an alternative educational program due to various personal needs: health issues, safety concerns, learning disabilities, cultural and/or philosophical concerns.

To individualize and pace instruction in order to achieve measurable student growth on the California Core State Standards.

To prepare students for a successful return to traditional school sites if desired.

Based on a review of performance, including student academic performance measures, local self-assessment tools, and stakeholder input, Charter Home School continues to show strong progress towards its vision for student learning and creating a caring and encouraging learning environment. There is significant evidence of greater attention and time dedicated to ensuring students' socio-emotional health and

learning. There was an increase of communication and collaboration with our assigned social worker, school psychologist to provide students and families more social interaction and access to mental health supports.

Reflections: Identified Need

Based on a review of performance, including student academic performance measures, local self-assessment tools, and stakeholder input, Charter Home School has determined instruction as being an area for improvement. Charter Home School's greatest areas of need are in Reading and Math. Across the school, significant numbers of students are reading below grade-level. The current educational program, including distance learning and modified in-person learning, has only aggravated this concern. These conclusions are based on results of the i-Ready assessment Reading and Math assessments. Critical to next year's planning is how to address this learning loss.

Goal 2: Supplemental Support

- 2.1 Purchase Books & Printing - Materials purchased for academic and intervention classes. This action addresses the ELA & math scores in i-Ready, state testing,
- 2.2 Certificated Staff - Teachers are placed by student need at schools. At the elementary level interventions are focused on K-6 reading instruction as well as supporting teachers in PD for reading instruction. The focus for Middle School is standard recovery. This action addresses the ELA & math scores in i-Ready, and state testing.

2.3 Online Subscriptions - allows students to have access to books beyond the books in the classroom. This action addresses the ELA scores in i-Ready and state testing.

2.4 Personal for Enrichment Opportunities - Continue to increase enrichment opportunities for low income, foster youth, and English Learners. This activity continues because stakeholders feel it is important for students to have a safe place to go socialize with their peers.

2.5 Library Materials - allows students and families to have access to books beyond the books in the classroom. This action addresses the ELA scores in i-Ready and state testing.

3.1 Materials & Supplies - Materials purchased for our site/facility to address and maintain a positive campus culture.

3.2 Parent Training - The focus of the Professional Learning in language development, reading and math instruction, and Social Emotional needs.

The following programs and services directly benefit English Learners, low-income students, and foster youth:

Administration – The Principal works closely with certificated and classified staff to create a climate of positive behavior and supports.

School Social Worker – The SSW works closely with the Principal and staff to support and enable positive behavior for Tier II and Tier III students.

Personalized learning and differentiated instruction – Student-centered instruction is a critical component of the Charter Home School instructional design and instructional philosophy.

School Psychologist – A school psychologist is on-site and average of two days per week providing support to students and teachers through observation, recommendations, and referrals.

Enrichment opportunities – Students enrolled at Charter Home are provided enrichment opportunities at all grade levels. Typically, these include field trips, TCOE events, and clubs. In our current context, the school offered more limited after-school opportunities via Zoom (Social Skills) and virtual field trips (e.g., SCICON) instead.

In order to address this condition of our low-income students, we will develop and implement a new attendance program that is designed to address some of the major causes of absenteeism, including lack of reliable transportation and food, as well as a school

climate that does not emphasize the importance of attendance. Goal N, Actions X, Y, and Z provide additional transportation and nutritional resources as well as a districtwide educational campaign on the benefits of high attendance rates. (Contributing Action(s))

These actions are being provided on an LEA-wide basis and we expect/hope that all students with less than a 100% attendance rate will benefit. However, because of the significantly lower attendance rate of low-income students, and because the actions meet needs most associated with the chronic stresses and experiences of a socio-economically disadvantaged status, we expect that the attendance rate for our low-income students will increase significantly more than the average attendance rate of all other students. (Measurable Outcomes [Effective In])
