CONNECTICUT GENERAL STATE STATUTE SEC. 12-81C

MUNICIPAL ORDINANCE MAY EXEMPT CERTAIN AMBULANCE-TYPE MOTOR VEHICLES.

THE LEGISLATIVE BODY OF ANY MUNICIPALITY MAY, BY ORDINANCE, EXEMPT FROM PERSONAL PROPERTY TAXATION ANY AMBULANCE-TYPE MOTOR VEHICLE WHICH IS USED EXCLUSIVELY FOR THE PURPOSE OF TRANSPORTING ANY MEDICALLY INCAPACITATED INDIVIDUAL, EXCEPT ANY SUCH VEHICLE USED TO TRANSPORT ANY SUCH INDIVIDUAL FOR PAYMENT.

TOWN OF ELLINGTON ORDINANCE PAGE 104 CONCERNING AMBULANCE-TYPE MOTOR VEHICLES

BE IT ENACTED BY THE TOWN OF ELLINGTON:

SECTION I - ANY AMBULANCE-TYPE MOTOR VEHICLE USED EXCLUSIVELY FOR THE PURPOSE OF TRANSPORTING ANY MEDICALLY INCAPACITATED INDIVIDUAL EXCEPTING ANY SUCH VEHICLE USED TO TRANSPORT ANY SUCH INDIVIDUAL FOR PAYMENT, IS HEREBY EXEMPT FROM PERSONAL PROPERTY TAXATION.

SECTION II - THIS ORDINANCE IS ENACTED PURSUANT TO THE PROVISIONS OF SECTION 12-81C OF THE CONNECTICUT GENERAL STATUTES.

SECTION III - THIS ORDINANCE BECAME EFFECTIVE ON AUGUST 1, 1983.
