

In-Home Behavioral Services



APPROACH: In-Home Behavioral Services (IHBS) are a home-based service committed to assisting families in identifying and reducing challenging behaviors. Our treatment approach is rooted in behavioral fundamentals and individualized to meet the unique needs of each child and family. Through collaboration and with dedication, care and compassion we assess and develop innovative treatment interventions, provide parent coaching, and monitor progress through a variety of data collection methods.

CLINICAL: We utilize the principles of Applied Behavioral Analysis (ABA) and Positive Behavioral Support (PBS) to facilitate the development of adaptive, functional, pro-social behavior. We approach treatment through a trauma informed lens and integrate the Attachment-Regulation-Competency (ARC) treatment framework into our behavioral practice. ABA also helps reduce everyday social problems and serious problem behaviors. A key component of ABA is the collection and analysis of data to inform treatment decisions.

SERVICES:

- Functional Behavior Assessment (FBA) for the youth
- An individualized Behavior Support Plan (BSP)
- Coaching and support for the youth's family to implement the BSP
- Monitoring of the BSP to determine its effectiveness
- Coordination with other providers
- Services are provided by JRI therapists skilled in understanding and treating challenging behaviors

ELIGIBILITY: Any Medicaid-eligible youth who meets established medical necessity criteria can receive IHBS. There is no requirement that youth have a "serious emotional disturbance" in order to receive this service, nor is the service reserved for youth whose behavioral challenges arise solely from developmental disabilities. Rather, IHBS has been designed with the clinical flexibility to offer highly individualized behavioral support services to youth with a broad array of emotional and developmental conditions, including those with co-morbid diagnoses.
