Election of Officers 2007            Kevin Brown asked for nominations for the office of President of the Board of School Trustees for 2007. Mark GiaQuinta nominated Stephen Corona and made a motion to close nominations, seconded by Pamela Martin-Diaz. Roll Call: Ayes, unanimous; nays, none. Stephen Corona was unanimously elected as President.

President Corona asked for nominations for the office of Vice President of the Board of School Trustees for 2007. Carol J. Coen nominated Mark GiaQuinta and made a motion to close nominations, seconded by Jon J. Olinger. Roll Call: Ayes, unanimous; nays, none. Mark GiaQuinta was unanimously elected as Vice President.

President Corona asked for nominations for the office of Secretary of the Board of School Trustees for 2007. Pamela Martin-Diaz nominated Mitch Sheppard, seconded by Kevin Brown. Mark GiaQuinta made a motion to close nominations, seconded by Jon J. Olinger. Roll Call: Ayes, unanimous; nays, none. Mitch Sheppard was unanimously elected as Secretary.

Appointment of Treasurer and Deputy Treasurers            Dr. Wendy Robinson, superintendent, presented the following recommendation concerning the Appointment of Treasurer and Deputy Treasurers:

**RECOMMENDATION:** It is recommended that Sherry L. Nidlinger be appointed as treasurer and Stefan W. Pittenger and Marcella A. Degitz as deputy treasurers for calendar year 2007, and that bonds for these positions be set as follows:

It is further recommended that the administration be granted authority to execute any corporate resolutions required by the various banking depositories.

**RELATED INFORMATION:** The General Powers Act of 1965 as Amended (IC 20-5-3-1), provides for appointment of a treasurer and deputy treasurers at the same time that the new board organizes.

Having two deputy treasurers better ensures timely deposits, investments, and continuity in money management affairs. Ms. Nidlinger serves as the full-time treasurer for the corporation while Mr. Pittenger and Ms. Degitz serve the district as director of fiscal affairs and supervisor of accounting, respectively.

IC 20-5-3-4 provides that the treasurer and deputy treasurers give a bond for the faithful performance of duty in an amount determined by the governing body. The cost of these bonds for 2007 will be \$1150.

A motion was made by Jon J. Olinger, seconded by Mitch Sheppard, that the recommendation concerning the Appointment of Treasurer and Deputy Treasurers be approved. Roll Call: Ayes, unanimous; nays, none.
