Oath of Office The Board of School Trustees of the Fort Wayne Community Schools met in regular session in the Lester L. Grile Administrative Center on Monday, January 12, 2009 at 6:02 p.m. President Mark GiaQuinta introduced Allen Superior Court Judge Stanley A. Levine who administered the Oath of Office to new Board member Becky Hill and returning Board members John Peirce and Stephen Corona.

Roll Call President GiaQuinta called the meeting to order with the Pledge of Allegiance and the following members in attendance:

Election of Officers 2009 President GiaQuinta asked for nominations for the office of President of the Board of School Trustees for 2009. Stephen Corona nominated Mark GiaQuinta, seconded by John Peirce. A motion was made by John Peirce to close the nominations for President, seconded by Stephen Corona. Roll Call: Ayes, unanimous; nays, none. Mark GiaQuinta was unanimously elected as President of the Board of School Trustees for 2009.

President GiaQuinta nominated Pamela Martin-Díaz for the office of Vice President and Mitch Sheppard for the office of Secretary, seconded by Stephen Corona. A motion was made by President GiaQuinta, seconded by John Peirce to close the nominations for Vice President and Secretary. Roll Call: Ayes, unanimous; nays, none. Pamela Martin-Díaz was unanimously elected as Vice President and Mitch Sheppard was unanimously elected as Secretary of the Board of School Trustees for 2009.

Appointment of Treasurer and Deputy Treasurers Dr. Wendy Robinson, superintendent, presented the following recommendation concerning the Appointment of Treasurer and Deputy Treasurers:

RECOMMENDATION: It is recommended that Sherry L. Nidlinger be appointed as treasurer and Stefan W. Pittenger and Marcella A. Degitz as deputy treasurers for calendar year 2009, and that bonds for these positions be set as follows:

Treasurer	\$200,000
Deputy Treasurers	\$50,000

It is further recommended that the administration be granted authority to execute any corporate resolutions required by the various banking depositories.

RELATED INFORMATION: The General Powers Act of 1965 as Amended (IC 20-5-3-1), provides for appointment of a treasurer and deputy treasurers at the same time that the new board organizes.

Having two deputy treasurers better ensures timely deposits, investments, and continuity in money management affairs. Ms. Nidlinger serves as the full-time treasurer for the corporation while Mr. Pittenger and Ms. Degitz serve the district as director of fiscal affairs and supervisor of accounting, respectively.

IC 20-5-3-4 provides that the treasurer and deputy treasurers give a bond for the faithful performance of duty in an amount determined by the governing body. The cost of these bonds for 2009 will be \$1,149.

A motion was made by Mitch Sheppard, seconded by Kevin Brown, that the recommendation concerning the Appointment of Treasurer and Deputy Treasurers be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

Recognition
of FWCS
Support
During Ice
Storm

RECOMMENDATION: It is recommended that the Board recognize the efforts of numerous FWCS employees who worked during the recent ice storm.

RELATED INFORMATION: The area experienced a dangerous ice storm on Friday, December 19, 2008, with the effects continuing through the next week. FWCS workers provided over 200 hours of overtime during this time. Seventeen of our schools lost power as a result of the storm.

Maintenance and Operations management was in constant communication with Indiana Michigan Power. The Maintenance and Operations crew worked tirelessly to provide temporary heat to prevent heating systems from freezing. Five schools experienced damage to their heating system components and require repairs.

In addition, South Side High School served as a Red Cross shelter during the storm. Administrators supported the shelter, Nutrition Services provided food, and custodians worked through December 28, including Christmas Eve and Christmas Day.

Director of Facilities Steve Parker, Coordinator of Capital Projects Mike Stetler and Manager of Maintenance and Operations Pat Casey were in the Board room and Dr. Robinson had them come forward to be recognized.

Award

RECOMMENDATION: It is recommended that the Board recognize a senior at Wayne High School for being named a 2008 Indiana High School Academic All-Star by the Indianapolis Colts.

RELATED INFORMATION: The Indiana High School Academic All-Star award recognizes student-athletes for their outstanding academic achievements. The Indiana Football Coaches Association nominated 90 players statewide for this honor, and a selection committee chose 24 of these who best represent the spirit of the award. Wayne senior Trent Gutting was one of these 24, and the only player in Allen County, to receive the award. He was honored by the Indianapolis Colts during halftime of their Dec. 14 game. Trent holds a 4.34 GPA on a 4.0 scale, because he takes Advanced Placement and college courses. He tutors fellow student-athletes and plans to attend Trine University to earn a double major in computer engineering and computer science.

RECOMMENDATION: It is recommended that the Board recognize five teachers for winning the ITT Industries Excellence in Education awards.

RELATED INFORMATION: The ITT Excellence in Education Award provides up to \$8,000 for projects related to science, technology, engineering, or mathematics. The awards are open to all Allen County public school teachers. This year, five teachers from three Fort Wayne Community Schools won awards. William Decker, economics and computer technology teacher from South Side High School, was awarded \$7,650 for his project titled "Youth Building Our Tomorrow Robotics." Dennis Fisher, science teacher at Elmhurst High School, received \$2,000 for his project called "Astronomy Class," which was to increase the students' knowledge in cognitive, math and reasoning skills in robotics. Blackhawk Middle School teachers Wendy Wichern, Ryan Hubley and Rolunda Suttle won \$2,000 for their project titled, "Technology Across the Curriculum: Making Math and Maps Make Sense."

Donations to
Anthis
Career
Center

Dr. Robinson presented the following recommendation concerning the Donations to Anthis Career Center:

RECOMMENDATION: It is recommended that the Board accept the 2008 major equipment donations to the Anthis Career Center.

RELATED INFORMATION: In April 2008, GM's Fort Wayne Assembly Plant donated a 2005 Chevrolet Silverado and a 2005 GMC Sierra with a combined estimated value of \$37,805.35. In December 2008, Karl Schmidt Unisia, Inc donated eight gas and diesel engines with a combined estimated value of \$43,500.

All donated vehicles and engines are disassembled and assembled by students as part of the hands on learning experience they receive at the Automotive Center. Anthis also receives donated vehicles from individuals each year that are used for the same purpose. After the vehicles and engines are past their useful life, they are sold to salvage yards as scrap.

A motion was made by Kevin Brown, seconded by Mitch Sheppard, that the recommendation concerning the Donations to Anthis Career Center be approved. Roll Call: Ayes, unanimous; nays, none.

Employee
Group Life
Insurance

Dr. Robinson presented the following recommendation concerning the Employee Group Life Insurance:

RECOMMENDATION: It is recommended that the Board approve MetLife as the group life insurance carrier for a four-year term, effective February 1, 2009 through January 31, 2013.

RELATED INFORMATION: The MetLife quote duplicates all of the schedules and policy provisions provided in the current contract. They have an A.M. Best rating of A+ and provide life insurance benefits to over 900 school districts nationwide. The four-year rate of \$0.155 per \$1,000 of coverage, which includes AD&D, represents a savings of 24.4% from our current rate of \$.205. The MetLife option amounts to approximately \$190,000 in annual savings over the current cost and approximately \$95,000 in savings compared to the renewal offer from BCS Life. They will also continue the voluntary dependent and supplemental products at the current rates.

BCS Life Insurance, the carrier since 2004, quoted their renewal at a rate of \$0.18 per \$1,000.00 of coverage with a 2-year rate guarantee.

Quotes were solicited from twenty-seven (27) companies. Responses were received from ten (10) with eleven (11) declining to quote. Five offered a reduction from the current rate.

It is important to note the current rate was guaranteed through 4/30/09, but with the substantial savings, it makes sense to move forward with the earlier date

A motion was made by Becky Hill, seconded by John Peirce, that the recommendation concerning the Employee Group Life Insurance be approved. Roll Call: Ayes, Stephen Corona, Becky Hill, Mitch Sheppard, John Peirce and Mark GiaQuinta; nays, none; abstaining, Kevin Brown.

Employee
Short-Term
Disability
Insurance

Dr. Robinson presented the following recommendations concerning the Employee Short-Term Disability Insurance and Employee Long-Term Disability Insurance:

RECOMMENDATION: It is recommended that the Board renew Reliance Standard Insurance Company as the employee short-term disability carrier for a one-year term, effective February 1, 2009 through January 31, 2010.

RELATED INFORMATION: Reliance Standard offered a rate of \$.56 per \$10.00 of coverage with a one-year rate guarantee. This is an increase of 47.4% from the previous rate of \$.38. Reliance has been our short-term disability carrier since 2007.

Quotes were solicited from twenty-seven companies. Fourteen declined to quote and seven provided competitive offers. Two carriers offered quotes with lower rates than Reliance's renewal. Those lower quotes amounted to approximately \$6,000 in annual savings; however, based upon several factors, it is felt that the monetary savings did not support the disruption and administrative difficulty of changing carriers and that FWCS will be better served at this time by remaining with the current carrier

Employee
Long-Term
Disability
Insurance

RECOMMENDATION: It is recommended that the Board renew Reliance Standard Insurance Company as the employee long-term disability carrier for a two-year term, effective February 1, 2009 through January 31, 2011.

RELATED INFORMATION: Reliance Standard offered a rate of \$.29 per \$100.00 of coverage with a two-year rate guarantee. This is an increase of 70.6% from the previous rate of \$.17. Reliance has been our long-term disability carrier since 2005.

Quotes were solicited from twenty-seven companies. Fifteen declined to quote and only one provided a lower offer. That lower quote amounted to approximately \$12,000 in annual premium savings, but it was contingent on the Short Term Disability being written as a package. If the Short Term Disability had been written with that carrier, the cost would have been over \$33,000 greater than the renewal offered by Reliance.

A motion was made by Mitch Sheppard, seconded by John Peirce, that the recommendations concerning the Employee Short-Term Disability Insurance and Employee Long-Term Disability Insurance be approved. Roll Call: Ayes, unanimous; nays, none.

Title IIB
Grant

Dr. Robinson presented the following recommendation concerning the Title IIB Grant:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of a Title IIB Math Science Partnership grant in the amount of \$497,026.73, in partnership with Indiana University Purdue University Fort Wayne (IPFW).

RELATED INFORMATION: This grant provides funds for professional development through graduate seminars in science content. The training will target all science teachers in grades 5-9 over the course of two years beginning with the summer of 2009. The grant also provides access to assessments aligned to science standards so that teachers can monitor student progress in learning the Indiana Academic Standards in science.

Through the partnership, FWCS and IPFW educators will improve the alignment of the science teacher preparation program of the university and the professional development that is offered to current teachers. It is the vision of the grant to have knowledgeable and well-trained teachers in every science classroom to increase science achievement and increase student interest in the study of science.

This competitive grant application supports District Goal I: *Achieve and Maintain Academic Excellence.*

A motion was made by John Peirce, seconded by Mitch Sheppard, that the recommendation concerning the Title IIB Grant be approved. Roll Call: Ayes, unanimous; nays, none.

Comments Superintendent Robinson introduced Steve Cobb who is joining FWCS as the Chief Operations Officer. Dr. Robinson and Board members thanked retiring Snider Athletic Director Mike Hawley for his years of service to Fort Wayne Community Schools. Whitney Young Early Childhood Center Principal Dianna Parker has accepted a part-time position closer to her home and Dr. Robinson thanked her for her work in getting the Reggio program at Young off the ground.

Kevin Brown would like 45 minutes at the next Board meeting to share information from conferences he has attended. Mr. Brown also commented that he was approached by a constituent about why he sits on the Bishop Luers side of a girl's basketball game to which he responded that he has a niece who plays for Luers. Mr. Brown would like FWCS to try to find the solution to address the education gap for African American and Hispanic males.

Steve Corona commented that he plans to reduce his travel expenses this year by not attending the annual Council of Urban Boards of Education (CUBE) conference in Texas. As a member of the National School Boards Association (NSBA) Board of Directors representing CUBE, much of his travel is paid. However, there are some costs incurred by the district and Steve would like to keep his yearly travel cost to the district at \$750.

John Peirce reported that he and Steve Corona have joined 50 men from the area in the "Real Men Read" program which aims to have third grade students reading at grade level. John reported that the program is modeled after a Chicago program and the Fort Wayne group of volunteers is very diverse.

Mark GiaQuinta thanked Kelly Soderland from *The Journal Gazette* for providing the Teacher Honor Roll as a positive way to highlight education. He congratulated Lori Hibbard a Jefferson Middle School Special Education teacher for receiving the honor this week. Mr. GiaQuinta also commented on the collaboration between FWCS and the Fort Wayne Civic Theater. In working with Todd Cummings, FWCS will receive \$2 off per ticket to Civic Theater productions.

Mr. GiaQuinta would like to begin the discussion with Board members about streamlining the monthly meetings. The suggested format would be business on the first meeting of the month and a working session for the second meeting. The working sessions would include topics of Balanced Scorecard, budget, facilities plan, high school redesign, summer school and others.
