The Board of School Trustees of the Fort Wayne Community Schools met in regular session in the Lester L. Grile Administrative Center on Monday, January 14, 2008 at 6:02 p.m. President Stephen Corona called the meeting to order with the following members in attendance:

Guests

President Corona introduced his son Vince Corona, a Sergeant in the Army on leave from Afghanistan; and Ben Giaquinta, a World War II veteran, and father of Board member Mark GiaQuinta who led us in the Pledge of Allegiance.

Election of Officers 2008 President Steve Corona asked for nominations for the office of President of the Board of School Trustees for 2008. Carol J. Coen nominated Mark GiaQuinta and made a motion to close nominations; seconded by Pamela Martin-Diaz. Roll Call: Ayes, unanimous; nays, none.

Stephen Corona asked for nominations for the office of Vice President of the Board of School Trustees for 2008. Mark GiaQuinta nominated Stephen Corona and made a motion to close the nominations; seconded by Carol J. Coen. Roll Call: Ayes, unanimous; nays, none.

Stephen Corona asked for nominations for the office of Secretary of the Board of School Trustees for 2008. Mark GiaQuinta nominated Pamela Martin-Diaz and made a motion to close the nominations; seconded by Carol J. Coen. Roll Call: Ayes, unanimous; nays, none.

Stephen Corona turned the meeting over to the new President, Mark GiaQuinta.

Dr. Wendy Robinson, superintendent, presented the following recommendation concerning the appointment of the Treasurer and Deputy Treasurers for the calendar year 2008:

Appointment of Treasurer and Deputy Treasurers **RECOMMENDATION:** It is recommended that Sherry L. Nidlinger be appointed as treasurer and Stefan W. Pittenger and Marcella A. Degitz as deputy treasurers for calendar year 2008, and that bonds for these positions be set as follows:

Treasurer \$200,000 Deputy Treasurers \$50,000

It is further recommended that the administration be granted authority to execute any corporate resolutions required by the various banking depositories.

RELATED INFORMATION: The General Powers Act of 1965 as Amended (IC 20-5-3-1), provides for appointment of a treasurer and deputy treasurers at the same time that the new Board organizes.

Having two deputy treasurers better ensures timely deposits, investments, and continuity in money management affairs. Ms. Nidlinger serves as the full-time treasurer for the corporation while Mr. Pittenger and Ms. Degitz serve the district as director of fiscal affairs and supervisor of accounting, respectively.

IC 20-5-3-4 provides that the treasurer and deputy treasurers give a bond for the faithful performance of duty in an amount determined by the governing body. The cost of these bonds for 2008 will be \$1150.

RECOMMENDATION: It is recommended that the Board approve an award for Lakeside Building Systems Replacement Project equipment purchase. Indiana Thermal Solutions, LLC was the low bidder for a total cost of \$398,900.

RELATED INFORMATION: Three equipment manufacturers were contacted to provide equipment only bids for the upcoming Lakeside Building Systems Replacement Project. Long lead times on some equipment prompted the need to order equipment before the construction phase of the contract is bid. In pre-ordering this equipment it places our order in the production line ensuring our equipment will be at the job site when needed. Once the construction is bid, the equipment purchase order will be given to the successful bidder to arrange delivery, installation, and warranty coverage.

RELATED INFORMATION: The current Irwin and South Side school sites are significantly below the state minimum acreage recommendation. The Portage site purchase is contiguous to our current site. Purchases of properties in these areas will allow flexibility for the school to expand parking lots or playing fields or to accommodate the potential replacement of the building. The agreed upon purchase prices must be the average of two appraisals or less. Funds are within budget.

Title II B Grant

Dr. Robinson presented the following recommendation concerning the Title II B Grant:

RECOMMENDATION: It is recommended that the Board approve submission and acceptance of an Indiana Department of Education Title II B grant in the amount of \$1,581,620. This grant was written in partnership with IPFW and will support two years of professional development for science teachers in grades 5 through 9.

RELATED INFORMATION: Indiana students are currently tested on their knowledge of science as a part of the ISTEP+ examination. It is the goal of the FWCS/IPFW partnership to increase student achievement by placing highly trained teachers in every science classroom.

Beginning in the summer of 2008, this grant will train teachers to effectively use the Indiana Science Standards in curriculum alignment and lesson development, the use of data to inform instruction, and to deepen teacher content knowledge of Chemistry and Biology. Working cooperatively, FWCS and IPFW will prepare an intensive summer course for FWCS science teachers and then provide follow-up training and consultation throughout the school year. The content of the summer course will then be embedded into the IPFW teacher preparation science courses. It is anticipated that approximately 100 FWCS teachers will participate in this program. Grant oversight for the district will be provided by the Curriculum department.
