Introduction

Dr. Robinson introduced Ann Barnes-Smith as Director of Special Education.

Long and Short-term Disability Insurance **RECOMMENDATION**: It is recommended that the Board renew Reliance Standard Insurance Company as the short and long-term disability carrier for a one-year term, effective February 1, 2012 through January 31, 2013.

RELATED INFORMATION: Based upon discussion and recommendation from our broker, Hylant Group, we plan to request quotes for all ancillary coverage, which includes both types of disability insurance as well as life and supplemental life insurance, for a February 1, 2013 effective date. Obtaining quotes for multiple lines of business at the same time can increase carrier discounting and place the district in a better position to obtain more competitive quotes from a larger pool of vendors.

Extending our agreement with Reliance for one year avoids the potential of moving disability coverage two years in a row by shopping both this year which could result in administrative difficulty and disruption to claimants.

In consideration for our decision not to shop the plan this year, Reliance has agreed to hold the current short-term rate of \$.49 per \$10.00 of coverage.

Based upon an incurred loss ratio of 127%, there will be a 5% increase in the long-term rate from \$.29 to \$.305 per \$100 of coverage. This is an annual increase of \$18,676.

Reliance Standard has been our short-term disability carrier since 2007 and our long-term disability carrier since 2005. In 2009, they agreed to extend our existing long-term rate through January 31, 2012 to coincide with the expiration of the short-term rate guarantee.

Appointment of Common Wage Committee **RECOMMENDATION**: It is recommended that the Board appoint the following members to the FWCS Common Wage Committee:

Ben Johnston, representing industry George Baldus, a taxpayer in the FWCS district

RELATED INFORMATION: FWCS must conduct a Common Wage hearing to determine the most common wage for each class of work on projects over \$250,000 in 2012. The projects must be bid within 90 days of the meeting. The common wage determines the minimum wage to be paid on upcoming FWCS construction projects.

By statute, there are five members of the Common Wage Committee. Three appointments are external, including one representing labor, one named by Associated Builders & Contractors, and one appointed by the County. Two members are appointed by FWCS, one representing industry and one taxpayer in our district.

Board member John Peirce reported that he is presenting information about the facilities project at different community venues. He and Dr. Robinson presented at the Chamber of Commerce. Mr. Peirce congratulated Northrop PTA for being awarded with a national grant to help middle and high school students become aware of opportunities in business and college.

Board member Becky Hill thanked the South Side Natatorium staff for the great programming provided to the schools and community.

Board member Julie Hollingsworth commented about an article she read regarding electric school buses. Ms. Hollingsworth also commented on an article about education in Finland.

Board President Mark GiaQuinta commented that he would like FWCS to keep abreast of what is happening with local charter schools by attending meetings of charter schools boards. Mr. GiaQuinta shared with Board members that he finds his work with them on the FWCS Board very enjoyable.

Dr. Robinson expressed condolences to the family of Conner Kitchen a Lane Middle School student who died in a snowmobile accident last week. Dr. Robinson thanked FWCS staff for helping the family, students and staff at Lane to cope with this tragedy.

Dr. Robinson reminded the public of the Choice Fair on Saturday, January 28 at Northrop High School from 1-4 p.m. Also, parent teacher conferences will take place on the afternoons/evenings of Wednesday, 2/1 and Thursday, 2/2 for all grades K-12. There will be no school on Friday, 2/3.

Dr. Robinson reminded Board members of the work session scheduled for Monday, 1/30 at 5:30 p.m. to provide Board members with a mid-year update on goals and central office work.
